## The Commonwealth of Massachusetts

In the Year Two Thousand Eleven

An Act relative to dissemination of criminal offender record information to providers of in-home cleaning services.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. Chapter 6 of the General Laws, as appearing in the 2006 Official  
2 Edition, is hereby amended by inserting after section 172I the following section:  
3 Section 172J Dissemination of criminal offender record information to providers of in-home  
4 cleaning services  
5 For the purposes of this section the following term shall have the following meaning: “provider  
6 of in-home cleaning services” any individual, corporation, limited liability company,  
7 organization or association contracting to provide cleaning services in private residences.

8           Notwithstanding any provision of section 172, criminal offender information shall be  
9 available to any provider of in-home cleaning services, for the purpose of obtaining criminal  
10 offender record information on an applicant under final consideration for, or an individual  
11 currently employed in, a position that involves the provision of in-home cleaning services. Any  
12 such provider of in-home cleaning services shall obtain conviction and arrest data from the  
13 criminal history systems board on an applicant under final consideration for a position that  
14 involves the provision in-home cleaning services. Any provider of in-home cleaning services  
15 which obtain information under this section shall prohibit the dissemination of such information  
16 for any purpose.

17           A provider of in-home cleaning services may employ an individual for a position that  
18 involves the provision of in-home cleaning services on a conditional basis prior to receiving the  
19 results of such individual's criminal offender record check from the criminal history systems  
20 board. No provider of in-home cleaning services shall be liable for civil damages to any  
21 individual so conditionally employed and subsequently discharged by reason of information  
22 received as a result of a criminal offender record information check completed pursuant to this  
23 section.
