An Act expanding protection under the Good Samaritan law for drug-related overdoses.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. Section 34A of Chapter 94C of the General Laws, as appearing in the 2014  
2 Official Edition, is hereby amended by inserting after the figure “35”, in lines 4 and 11, the  
3 following:-

4 “, or found in violation of a condition of probation or pre-trial release as determined by  
5 the courts or a condition of parole as determined by the Parole board,”

6 SECTION 2. Said Section 34A of Chapter 94C of the General Laws, as so appearing, is  
7 hereby further amended by inserting after the word “substance”, in lines 5 and 12, the following  
8 words:-

9 “or violation”
