AMENDMENT NO. 1

On page 1, in line 2, strike "- Optional" and substitute "Officials -"; in line 11, after "individuals;" insert "providing that membership in the Employees' Pension System is prohibited for certain individuals;"; in line 16, after "regulations;" insert "requiring the State Retirement Agency to provide a certain report on or before a certain date to the Joint Committee on Pensions;"; and in line 17, strike "optional".

AMENDMENT NO. 2

On page 4, strike beginning with the colon in line 2 down through the comma in line 12; strike beginning with "OR" in line 18 down through "LATER" in line 19; and in line 28, after "(2)" insert "(1)".

AMENDMENT NO. 3

On page 4, after line 30, insert:

- "(4) MEMBERSHIP IN THE EMPLOYEES' PENSION SYSTEM IS PROHIBITED FOR AN INDIVIDUAL WHO:
- (1) BEGINS SERVING IN A POSITION LISTED IN PARAGRAPH
 (1) OF THIS SUBSECTION ON OR AFTER JULY 1, 2004, BUT BEFORE JULY 1, 2014;
- (II) REMAINS IN A POSITION LISTED IN PARAGRAPH (1) OF THIS SUBSECTION ON OR AFTER JULY 1, 2014; AND

(III) IS NOT ENROLLED IN THE EMPLOYEES' PENSION SYSTEM.".

On page 5, in lines 1 and 14, strike "(4)" and "(5)", respectively, and substitute "(5)" and "(6)", respectively; in line 1, after "UNDER" insert "PARAGRAPH (2)(II) OF"; in line 8, after "SYSTEM" insert "WHILE EMPLOYED IN ONE OF THE POSITIONS LISTED UNDER PARAGRAPH (1) OF THIS SUBSECTION"; and in line 9, after "UNDER" insert "PARAGRAPH (4) OF THIS SUBSECTION OR".

AMENDMENT NO. 4

On page 5, after line 15, insert:

"SECTION 2. AND BE IT FURTHER ENACTED, That:

- (a) The State Retirement Agency shall:
- (1) <u>conduct a study regarding the membership of elected and</u> appointed officials in the Employees' Pension System, including:
- (i) the elected and appointed officials who are required to join the Employees' Pension System as a condition of employment under current law;
- (ii) the elected and appointed officials who have optional membership in the Employees' Pension System under current law; and
- (iii) the impact of the 10-year vesting period under the Reformed Contributory Pension Benefit on the elected and appointed officials who began serving on or after July 1, 2011; and

- (2) <u>make recommendations regarding suggested statutory changes</u> relating to the membership of elected and appointed officials in the Employees' Pension System.
- (b) On or before December 1, 2014, the State Retirement Agency shall report its findings and recommendations to the Joint Committee on Pensions.";

and in line 16, strike "2." and substitute "3.".
