AMENDMENT NO. 2

On page 2, strike in their entirety lines 27 through 29, inclusive.

On page 3, in lines, 1, 3, 9, 11, 12, and 16, strike "(G)", "(H)", "(I)", "(J)", "(K)", and "(L)", respectively, and substitute "(F)", "(G)", "(H)", "(I)", "(J)", and "(K)", respectively; in line 10, after "WELL" insert "THAT IS A SOURCE OF POTABLE WATER"; in line 13, after the semicolon insert "AND"; strike beginning with the semicolon in line 14 down through "CONTAMINATION" in line 15; in line 18, after the first "A" insert "STATE-APPROVED WATER SAMPLER AND A"; in line 20, after the first "THE" insert "MINIMUM"; and strike beginning with "IS" in line 20 down through "26.04.04.30" in line 22 and substitute "CRITERIA INCLUDE BACTERIA, NITRATE, AND TURBIDITY".
