2. <u>A TRAINING WAGE UNDER REGULATIONS THAT</u> <u>THE COMMISSIONER ADOPTS THAT INCLUDE THE CONDITIONS AND</u> <u>LIMITATIONS AUTHORIZED UNDER THE FEDERAL FAIR LABOR STANDARDS</u> <u>AMENDMENTS OF 1989.</u>";
