<u>AMENDMENTS TO HOUSE BILL 978</u> (First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 11, strike "during a certain event" and substitute "<u>while</u> <u>selling wine or providing samples at a farmers' market</u>"; in line 17, after "event;" insert "<u>authorizing the Office of the Comptroller to adopt regulations to require a</u> <u>winery off-site permit holder to notify a certain board of license commissioners of its</u> <u>intention to attend an off-site event;</u>"; and strike beginning with "requiring" in line 28 down through "event;" in line 29.

On page 2, in line 5, after "event;" insert "<u>establishing certain limits on the</u> <u>attendance at a certain number of events each calendar year by a winery off-site</u> <u>permit holder;</u>"; and in line 19, strike "and 2-103" and substitute "<u>, 2-103, and 2-104</u>".

AMENDMENT NO. 2

On page 9, in line 26, strike "IN SEALED CONTAINERS"; in line 30, strike "BY THE GLASS"; and in line 31, strike "ON-PREMISES" and substitute "<u>ON- AND OFF-</u><u>PREMISES</u>".

On page 10, in lines 1 and 2, strike "AN EVENT LISTED" and substitute "<u>A</u> <u>FARMERS' MARKET AS PROVIDED</u>"; in line 2, strike "(E)" and substitute "(E)(4)"; in line 5, after "THE" insert "<u>WINERY OFFSITE</u>"; strike beginning with the colon in line 14 down through "LISTED" in line 15 and substitute "<u>LISTED</u>"; and strike beginning with the semicolon in line 16 down through the third "COUNTY" in line 18.

On page 11, after line 9, insert:

"(I) <u>The Comptroller may adopt regulations to require the</u> <u>PERMIT HOLDER TO NOTIFY THE BOARD OF LICENSE COMMISSIONERS IN THE</u> <u>COUNTY WHERE THE EVENT IS BEING HELD OF ITS INTENTION TO ATTEND AN</u> <u>OFF-SITE EVENT.</u>";

in line 12, strike "MAY ONLY" and substitute "<u>SHALL</u>"; in line 13, after "ORGANIZATION" insert "<u>, AS DEFINED BY § 501(C) OF THE INTERNAL REVENUE</u> <u>CODE</u>"; in line 23, after the semicolon, insert "<u>AND</u>"; in line 24, strike "IN A SEALED CONTAINER"; in line 25, after "FOR" insert "<u>ON- AND</u>"; and strike beginning with the semicolon in line 25 down through "CONSUMPTION" in line 27.

AMENDMENT NO. 3

On page 12, in line 7, strike "(1)"; and strike in their entirety lines 10 through 13, inclusive.

On page 12, after line 29, insert:

"<u>2-104.</u>

EACH CALENDAR YEAR, ATTENDANCE AT AN EVENT DESCRIBED IN § 2-102(E)(3) OF THIS TITLE AND AT A WINE FESTIVAL DESCRIBED IN § 2-103 OF THIS TITLE BY A HOLDER OF A WINERY OFF-SITE PERMIT SHALL BE LIMITED TO ATTENDANCE AT NO MORE THAN:

(1) <u>21 EVENTS STATEWIDE; AND</u>

(2) <u>NINE EVENTS AT ANY SINGLE VENUE.</u>".

On page 13, in line 9, strike "July" and substitute "June".
