Serving 53,719 clients in the region, the National Center for Children and Families (NCCF) creates total, healthy living environments for vulnerable children, youth and families, and the quality of life which empowers their ability to thrive and demonstrate responsibility. We provide 24 programs within four service divisions: Adolescent, Community Based, Family, and Foster Care and Adoption Services, addressing homelessness, domestic violence, out-of-home placements of maltreated children and youth, transitional housing and family shelter, youth development, wellness, and school based prevention. NCCFs expertise is our ability to provide services that empower clients to positively transform their lives, cultivated by our work with at-risk populations.

11. Description and Purpose of Project (Limit length to visible area)

Resurfacing and repair of NCCFs circular driveway is needed to remedy the numerous currently exist and to reduce the increasing legal liability. NCCF makes temporary repairs; however, these efforts are short-term due to weather conditions and normal wear and tear. Staff and agency vehicles are at risk for damage with the continued existence of potholes. Damaged vehicles affect the child care team's ability to transport clients to essential services. Generators are needed to ensure continued power to the two cottages that house the 20 boys referred to NCCF from county Child Welfare departments from across the State. Power is essential for maintaining air conditioning, heating, refrigeration for safe food storage and power for food preparation. Previously, NCCF has had to relocate the boys to hotels while PEPCO restores power to the buildings. This relocation disrupts the programming and can be destabilizing to the vulnerable youth we serve.

28. Comments

The Bethesda Administrative Campus is a hub of activity for NCCF, housing a high intensity structured living community for 20 adolescent males at a time, who come from an average of 6 or 7 Maryland counties. It also houses the largest homeless emergency family shelter in Montgomery County, average 13 families with a mean length of stay of 90 days. NCCF's Maryland Treatment foster care program maintains its offices at this site. All key administrative offices are housed on this site: administration and executive management, facilities management, finance, human resources. As required by COMAR, the youth activities center is located at this site, as well as the training division which serves over 200 foster parents, 220 employees, and 2,500 volunteers. Community meetings are conducted in the gymnasium and includes county and state officials. Quarterly Board meetings and special events, e.g., domestic violence prevention, social work recognition, holiday celebrations with clients and volunteers, etc. All regulatory monitors, auditors, and peer reviewers for purposes of accreditation utilize the Bethesda offices. Volunteers also utilize the campus to provide recreational activities for the clients, or to fundraise, e.g., a flea market in the community, and bring their families to assist in Thanksgiving basket stuffing, gift wrapping, toy distribution (for example, Cabin John Fire Department brings Santa Claus, on a fire truck, bearing gifts for specific children). NCCF also conducts a Workforce development program, Heart and Soul Catering, which prepares youth and young adults in our off site programs to become cooks and food handlers, while preparing to enter the workforce.

This project is essential for safety purposes given the significant exposure which is present above. NCCF's insurance carrier strongly, strongly recommended immediate corrective action. Such potential liability would also increase our insurance rates. This project would ensure that NCCF maintains its aesthetic as an attractive venue, to be more compatible with the surrounding residential community. Our clients have enough challenges without feeling like a second class resident within our community.

Finally, due to the aging trees and older infrastructure in Bethesda, this NCCF campus often is subjected to power outages, which may last for several days, routinely. The generators will reinforce housing stability for our challenged youth, as well NCCF's ability to comply with all of the requirements of its contract with Maryland Department of Human Services.
