A BILL ENTITLED

1 AN ACT concerning

2 **Congressional Districting Plan**

3 FOR the purpose of establishing the composition of the eight districts in the State of
4 Maryland for the election of members to the United States House of
5 Representatives; specifying certain ward, election district, and precinct
6 boundaries; making this Act an emergency measure; and generally relating to
7 the reconfiguration of congressional districts in the State.

23 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
24 MARYLAND, That Section(s) 8–702 through 8–709 of Article – Election Law of the
25 Annotated Code of Maryland be repealed.

1 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland
2 read as follows:

3 **Article – Election Law**

4 8–701.

5 (a) The population count used after each decennial census for the purpose of
6 creating the congressional districting plan used to elect the State’s Representatives in
7 Congress:

8 (1) may not include individuals who:

9 (i) were incarcerated in State or federal correctional facilities,
10 as determined by the decennial census; and

11 (ii) were not residents of the State before their incarceration;
12 and

13 (2) shall count individuals incarcerated in the State or federal
14 correctional facilities, as determined by the decennial census, at their last known
15 residence before incarceration if the individuals were residents of the State.

16 (b) The State is divided into eight districts for the election of the State’s
17 Representatives in Congress.

18 (c) (1) The descriptions of congressional districts in this subtitle include
19 the references indicated.

20 (2) (I) The references to:

21 [(i)] 1. election districts and wards are to the geographical
22 boundaries of the election districts and wards as they existed on April 1, [2000] 2010;
23 and

24 [(ii)] 2. precincts are to the geographical boundaries of the
25 precincts as reviewed and certified by the local boards or their designees, before they
26 were reported to the U.S. Bureau of the Census as part of the [2000] 2010 census
27 redistricting data program and as those precinct lines are specifically indicated in the
28 P.L. 94–171 data or shown on the P.L. 94–171 census block maps provided by the U.S.
29 Bureau of the Census and as reviewed and corrected by the Maryland Department of
30 Planning.
