- 24 (2) ALLOW AN ELIGIBLE ENERGY CUSTOMER 45 DAYS TO RESPOND TO 25 A REQUEST FOR ADDITIONAL INFORMATION; AND
- 26 (3) MAINTAIN RECORDS ORGANIZED BY COUNTY, INCLUDING 27 RECORDS ON THE NUMBER OF HOUSEHOLDS DURING THE PREVIOUS YEAR:
