N1 5lr1070 HB 412/14 - ENV By: Delegates McMillan, Davis, and Holmes Introduced and read first time: February 13, 2015 Assigned to: Environment and Transportation Committee Report: Favorable with amendments House action: Adopted Read second time: March 20, 2015 CHAPTER AN ACT concerning Real Property - Condominiums and Homeowners Associations - Disclosures to Purchasers on Resale of Unit or Lot – Limitation on Fees FOR the purpose of limiting the amount of the fee that a condominium council of unit owners may charge a unit owner to furnish a certain certificate; requiring a homeowners association or certain other persons to provide certain information within a certain number of days after a certain request by a lot owner and receipt of a certain fee; providing that a council of unit owners is entitled to charge certain fees for an inspection of a unit and for ensuring the completion of a certain inspection and preparation and delivery of a certain certificate within a certain period of time; providing that a homeowners association is entitled to a certain fee for providing certain information; providing that a homeowners association is entitled to a certain fee for providing certain information within a certain period of time; limiting the liability of a council of unit owners or a homeowners association for certain errors and omissions; and generally relating to the resale of a condominium unit or a lot located in a certain development. 8 9 10 11 12	(a) Except as provided in subsection (b) of this section, a contract for the resale of a unit by a unit owner other than a developer is not enforceable unless the contract of sale contains in conspicuous type a notice in the form specified in subsection (g)(1) of this section, and the unit owner furnishes to the purchaser not later than 15 days prior to closing:
13	(1) A copy of the declaration (other than the plats);
14	(2) The bylaws;
15	(3) The rules or regulations of the condominium;

- 7 (ix) A statement as to whether the council of unit owners has 8 knowledge that any alteration or improvement to the unit or to the limited common 9 elements assigned to the unit violates any provision of the declaration, bylaws, or rules or 10 regulations;
- 11 (x) A statement as to whether the council of unit owners has 12 knowledge of any violation of the health or building codes with respect to the unit, the 13 limited common elements assigned to the unit, or any other portion of the condominium;
- 14 (xi) A statement of the remaining term of any leasehold estate 15 affecting the condominium and the provisions governing any extension or renewal thereof; 16 and
- 17 (xii) A description of any recreational or other facilities which are to 18 be used by the unit owners or maintained by them or the council of unit owners, and a statement as to whether or not they are to be a part of the common elements;
- 20 (5) A statement by the unit owner as to whether the unit owner has 21 knowledge:
- 22 (i) That any alteration to the unit or to the limited common 23 elements assigned to the unit violates any provision of the declaration, bylaws, or rules and 24 regulations;

- 31 (b) A contract for the resale by a unit owner other than a developer of a unit in a 32 condominium containing less than 7 units is not enforceable unless the contract of sale 33 contains in conspicuous type a notice in the form specified in subsection (g)(2) of this 34 section, and the unit owner furnishes to the purchaser not later than 15 days prior to 35 closing:

- 10 (a) A contract for the resale of a lot within a development, or for the initial sale of 11 a lot within a development containing 12 or fewer lots, to a member of the public who 12 intends to occupy or rent the lot for residential purposes, is not enforceable by the vendor 13 unless:
- 14 (1) The purchaser is given, on or before entering into the contract for the 15 sale of such lot, or within 20 calendar days of entering into the contract, the disclosures set 16 forth in subsection (b) of this section;
- 17 (2) The purchaser is given any changes in mandatory fees and payments 18 exceeding 10 percent of the amount previously stated to exist and any other substantial 19 and material amendment to the disclosures after they become known to the vendor; and
- 20 (3) The contract of sale contains a notice in conspicuous type, which shall include bold and underscored type, in a form substantially the same as the following:

"This sale is subject to the requirements of the Maryland Homeowners Association Act (the "Act"). The Act requires that the seller disclose to you at or before the time the contract is entered into, or within 20 calendar days of entering into the contract, certain information concerning the development in which the lot you are purchasing is located. The content of the information to be disclosed is set forth in § 11B–106(b) of the Act (the "MHAA information") as follows:

(The notice shall include at this point the text of § 11B–106(b) in its entirety).

If you have not received all of the MHAA information 5 calendar days or more before entering into the contract, you have 5 calendar days to cancel this contract after receiving all of the MHAA information. You must cancel the contract in writing, but you do not have to state a reason. The seller must also provide you with notice of any changes in mandatory fees exceeding 10% of the amount previously stated to exist and copies of any other substantial and material amendment to the information provided to you. You have 3 calendar days to cancel this contract after receiving notice of any changes in mandatory fees, or copies of any other substantial and material amendment to the MHAA information which adversely affects you. If you do cancel the contract you will be entitled to a refund of any deposit you made on account of the contract. However, unless you return the MHAA

information to the seller when you cancel the contract, the seller may keep out of your deposit the cost of reproducing the MHAA information, or \$100, whichever amount is less.

By purchasing a lot within this development, you will automatically be subject to various rights, responsibilities, and obligations, including the obligation to pay certain assessments to the homeowners association within the development. The lot you are purchasing may have restrictions on:

- 7 (1) Architectural changes, design, color, landscaping, or appearance;
- 8 (2) Occupancy density;
- 9 (3) Kind, number, or use of vehicles;
- 10 (4) Renting, leasing, mortgaging, or conveying property;
- 11 (5) Commercial activity; or
- 12 (6) Other matters.
- You should review the MHAA information carefully to ascertain your rights, responsibilities, and obligations within the development."
- 15 (b) The vendor shall provide the purchaser the following information in writing:
- 16 (1) A statement as to whether the lot is located within a development;
- 17 (2) (i) The current monthly fees or assessments imposed by the 18 homeowners association upon the lot;
- 19 (ii) The total amount of fees, assessments, and other charges 20 imposed by the homeowners association upon the lot during the prior fiscal year of the 21 homeowners association; and
- 22 (iii) A statement of whether any of the fees, assessments, or other 23 charges against the lot are delinquent;
- 24 (3) The name, address, and telephone number of the management agent of 25 the homeowners association, or other officer or agent authorized by the homeowners 26 association to provide to members of the public, information regarding the homeowners 27 association and the development, or a statement that no agent or officer is presently so 28 authorized by the homeowners association;
- 29 (4) A statement as to whether the owner has actual knowledge of:
- 30 (i) The existence of any unsatisfied judgments or pending lawsuits 31 against the homeowners association; and

- 1 (ii) Any pending claims, covenant violations actions, or notices of 2 default against the lot; and
  - (5) A copy of:

- 4 (i) The articles of incorporation, the declaration, and all recorded covenants and restrictions of the primary development, and of other related developments to the extent reasonably available, to which the purchaser shall become obligated on becoming an owner of the lot, including a statement that these obligations are enforceable against an owner's tenants, if applicable; and
- 9 (ii) The bylaws and rules of the primary development, and of other 10 related developments to the extent reasonably available, to which the purchaser shall 11 become obligated on becoming an owner of the lot, including a statement that these 12 obligations are enforceable against an owner and the owner's tenants, if applicable.
- (C) 13 **(1)** THE HOMEOWNERS ASSOCIATION, THE MANAGEMENT AGENT OF 14 THE HOMEOWNERS ASSOCIATION, OR ANY OTHER AUTHORIZED OFFICER OR AGENT 15 OF THE HOMEOWNERS ASSOCIATION, WITHIN 20 DAYS AFTER A WRITTEN REQUEST 16 BY A LOT OWNER AND RECEIPT OF A REASONABLE FEE, NOT EXCEEDING THE LESSER 17 OF \$250 \$175 OR THE ACTUAL COST OF PROVIDING THE INFORMATION, SHALL 18 PROVIDE ANY INFORMATION NECESSARY TO ENABLE THE LOT OWNER TO COMPLY 19 WITH THE INFORMATION LISTED UNDER SUBSECTION (B) OF THIS SECTION.
- 20 (2) IN ADDITION TO THE FEE UNDER PARAGRAPH (1) OF THIS
  21 SUBSECTION, THE HOMEOWNERS ASSOCIATION IS ENTITLED TO A REASONABLE FEE

- 24 (3) ANY LIABILITY OF THE HOMEOWNERS ASSOCIATION FOR AN ERROR OR OMISSION IN THE INFORMATION PROVIDED SHALL BE LIMITED TO THE AMOUNT OF THE FEES PAID FOR THE INFORMATION.
- [(c)] (D) (1) Within 30 calendar days of any resale transfer of a lot within a development, the transferor shall notify the homeowners association for the primary development of the transfer.
- 30 (2) The notification shall include, to the extent reasonably available, the name and address of the transferee, the name and forwarding address of the transferor, the date of transfer, the name and address of any mortgagee, and the proportionate amount of any outstanding homeowners association fee or assessment assumed by each of the parties to the transaction.
- The requirements of subsection (b) of this section shall be deemed to have been fulfilled if the information required to be disclosed is provided to the purchaser
