1 AN ACT concerning

2 **Security Guard Agencies, Security Guard Employers, and Security Guards –**
3 **Standards and Certifications**

4 FOR the purpose of requiring an individual who provides security guard services to the
5 individual's employer to be certified as a security guard, subject to a certain
6 exception; regulating certain security guard employers; altering the certification and
7 renewal standards for security guards; requiring the Maryland Police Training and
8 Standards Commission to identify or establish certain training programs for the
9 certification of security guards; requiring security guards to complete certain
10 security training programs; and generally relating to the regulation of security guard
11 agencies, security guard employers, and security guards.

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
2 That the Laws of Maryland read as follows:

3 **Article – Business Occupations and Professions**

4 19–101.

5 (a) In this title the following words have the meanings indicated.

6 (b) “Central Repository” means the Criminal Justice Information System Central
7 Repository of the Department of Public Safety and Correctional Services.

8 (c) “Certification card” means a card issued by the Secretary under § 19–405 of
9 this title to an individual certified as a security guard.

10 (d) “Firm” means a partnership or corporation.

11 (e) “Firm member” means a partner of a partnership or an officer or director of a
12 corporation.

13 (f) “License” means, unless the context requires otherwise, a license issued by the
14 Secretary to conduct a business to provide security guard services.

15 (g) “Licensed security guard agency” means a person who is licensed by the
16 Secretary to conduct a business that provides security guard services.

17 (h) **“POLICE OFFICER” HAS THE MEANING STATED IN § 2–101 OF THE**
18 **CRIMINAL PROCEDURE ARTICLE.**

19 (i) “Representative member” means a firm member who is appointed under §
20 19–302(b) of this title to act on behalf of the firm.

21 [(i)] (j) “Secretary”, unless the context requires otherwise, means the Secretary
22 of State Police.

23 [(j)] (k) “Security guard” means an individual who [provides security guard
24 services to any person on behalf of a security guard agency], regardless of whether the
25 individual is described as a security guard, watchman, or private patrolman or by other
26 title:

27 (1) (i) IS AN EMPLOYEE OF A SECURITY GUARD AGENCY; AND

28 (ii) PROVIDES SECURITY GUARD SERVICES TO ANOTHER
29 PERSON ON BEHALF OF THE SECURITY GUARD AGENCY; OR

30 (2) (i) IS AN EMPLOYEE OF A SECURITY GUARD EMPLOYER; AND

1 **(II) PROVIDES SECURITY GUARD SERVICES TO THE SECURITY**
2 **GUARD EMPLOYER.**

3 **[(k)] (L)** (1) “Security guard agency” means a person who conducts a business
4 that provides security guard services.

5 (2) “Security guard agency” does not include:

6 **(I)** a person that is primarily engaged in the business of owning,
7 maintaining, or otherwise managing property; **OR**

8 **(II)** **A SECURITY GUARD EMPLOYER.**

9 **(M) (1) “SECURITY GUARD EMPLOYER” MEANS A PERSON WHO EMPLOYS**
10 **SECURITY GUARDS ONLY TO PROVIDE SECURITY GUARD SERVICES TO THE PERSON.**

11 **(2) “SECURITY GUARD EMPLOYER” DOES NOT INCLUDE A SECURITY**
12 **GUARD AGENCY.**

13 **[(l)] (N)** “Security guard services” includes any activity that is performed for
14 compensation as a security guard to protect any individual or property, except the activities
15 of an individual while performing as:

16 (1) a marine guard or ship watchman, regardless of whether the guard or
17 watchman is stationed aboard a ship or on a pier; ~~or~~

18 (2) a special police officer appointed and while performing under Title 3,
19 Subtitle 3 of the Public Safety Article or § 16–16 of the Code of Public Local Laws of
20 Baltimore City; **OR**

21 **(3) AN UNARMED EMPLOYEE OF A BAR, TAVERN, OR RESTAURANT.**

22 19–401.

23 (a) Except as provided under subsection (b) of this section, a licensed security
24 guard agency may provide an individual for hire as a security guard only if the individual
25 is certified by the Secretary as a security guard.

26 (b) A licensed security guard agency may provide an uncertified individual for
27 hire as a security guard if:

28 (1) (i) the security guard agency has submitted to the Secretary the
29 application of the individual for certification as a security guard, fingerprint cards, and
30 records fee as required under § 19–402(b) of this subtitle; and

1 (ii) the Secretary has not disapproved the application; or

2 (2) the individual has obtained and currently possesses certification by the
3 Maryland Police Training and Standards Commission as a police officer.

4 **(C) EXCEPT AS PROVIDED UNDER SUBSECTION (D) OF THIS SECTION, A**
5 **SECURITY GUARD EMPLOYER MAY EMPLOY A SECURITY GUARD TO PROVIDE**
6 **SECURITY GUARD SERVICES ONLY IF THE INDIVIDUAL IS CERTIFIED BY THE**
7 **SECRETARY AS A SECURITY GUARD.**

8 **(D) A SECURITY GUARD EMPLOYER MAY EMPLOY AN UNCERTIFIED**
9 **SECURITY GUARD TO PROVIDE SECURITY GUARD SERVICES FOR THE SECURITY**
10 **GUARD EMPLOYER IF:**

11 **(1) (I) THE SECURITY GUARD EMPLOYER HAS SUBMITTED TO THE**
12 **SECRETARY THE APPLICATION OF THE INDIVIDUAL FOR CERTIFICATION AS A**
13 **SECURITY GUARD, FINGERPRINT CARDS, AND RECORDS FEE AS REQUIRED UNDER §**
14 **19-402(B) OF THIS SUBTITLE; AND**

15 **(II) THE SECRETARY HAS NOT DISAPPROVED THE**
16 **APPLICATION; OR**

17 **(2) THE INDIVIDUAL HAS OBTAINED AND CURRENTLY POSSESSES**
18 **CERTIFICATION BY THE MARYLAND POLICE TRAINING AND STANDARDS**
19 **COMMISSION AS A POLICE OFFICER.**

20 **(E) THIS SUBTITLE DOES NOT PROHIBIT A SECURITY GUARD EMPLOYER**
21 **FROM HIRING SECURITY GUARDS FROM A LICENSED SECURITY GUARD AGENCY.**

22 19-402.

23 (a) To qualify for certification as a security guard, an individual shall:

24 (1) meet the standards set by the Secretary;

25 (2) be an employee of or an applicant for employment with a licensed
26 security guard agency **OR A SECURITY GUARD EMPLOYER;**

27 (3) be of good moral character and reputation;

28 (4) submit to the licensed security guard agency **OR THE SECURITY**
29 **GUARD EMPLOYER,** for forwarding to the Secretary:

30 (i) a sworn application on the form the Secretary provides;

1 (ii) the fingerprints required under § 19–304(c) of this title; [and]

2 (iii) a nonrefundable application fee of \$15; [and]

3 (IV) A DECLARATION UNDER THE PENALTIES OF PERJURY
4 STATING WHETHER:

5 1. THE INDIVIDUAL HAS BEEN CONVICTED OF:

6 A. A DISQUALIFYING CRIME, UNDER § 5–101 OF THE
7 PUBLIC SAFETY ARTICLE; OR

8 B. A CRIME OF VIOLENCE, UNDER § 14–101 OF THE
9 CRIMINAL LAW ARTICLE;

10 2. IF CURRENTLY OR FORMERLY EMPLOYED AS A
11 POLICE OFFICER, THE INDIVIDUAL HAS HAD ANY FORMAL FINDINGS BY A COURT,
12 HEARING BOARD, OR OTHER GOVERNMENTAL ENTITY OF UNLAWFUL OR EXCESSIVE
13 USE OF FORCE OR OF MAKING A FALSE STATEMENT DURING THE INDIVIDUAL’S
14 EMPLOYMENT WITH THE LAW ENFORCEMENT AGENCY; AND

15 3. THE INDIVIDUAL PLANS TO CARRY A HANDGUN IN THE
16 COURSE OF PROVIDING SECURITY GUARD SERVICES; AND

17 (V) DOCUMENTATION THAT THE INDIVIDUAL HAS EITHER:

18 1. SATISFACTORILY COMPLETED 12 HOURS OF INITIAL
19 SECURITY TRAINING THAT IS APPROVED BY THE MARYLAND POLICE TRAINING AND
20 STANDARDS COMMISSION UNDER § 19–412 OF THIS SUBTITLE; OR

21 2. BEEN EMPLOYED AS A POLICE OFFICER IN THE 3
22 YEARS IMMEDIATELY PRECEDING THE APPLICATION;

23 (5) pay to the licensed security guard agency OR THE SECURITY GUARD
24 EMPLOYER, for forwarding to the Secretary, the fees authorized under § 19–304(c) of this
25 title; AND

26 (6) BE AT LEAST 18 YEARS OLD.

27 (b) On receipt from an applicant for certification as a security guard, a licensed
28 security guard agency OR SECURITY GUARD EMPLOYER shall forward to the Secretary
29 the applicant’s application form, fingerprint cards, and criminal history records check fees.

30 (C) (1) SUBJECT TO PARAGRAPH (2) OF THIS SUBSECTION, AN
31 APPLICANT FOR CERTIFICATION AS A SECURITY GUARD SHALL COMPLETE 12 HOURS

1 OF INITIAL SECURITY TRAINING THAT IS APPROVED BY THE MARYLAND POLICE
2 TRAINING AND STANDARDS COMMISSION UNDER § 19-412 OF THIS SUBTITLE.

3 (2) AN APPLICANT FOR CERTIFICATION MAY NOT BE REQUIRED TO
4 COMPLETE THE TRAINING SPECIFIED IN PARAGRAPH (1) OF THIS SUBSECTION IF
5 THE APPLICANT:

6 (I) HAS BEEN EMPLOYED AS A POLICE OFFICER IN THE 3 YEARS
7 IMMEDIATELY PRECEDING THE APPLICATION; AND

8 (II) PROVIDES SUPPORTING DOCUMENTATION WITH THE
9 APPLICATION FOR CERTIFICATION AS A SECURITY GUARD IN ACCORDANCE WITH
10 SUBSECTION (A)(4)(V)2 OF THIS SECTION.

11 19-404.1.

12 (a) By regulation, the Secretary shall stagger the terms of the certifications.

13 (b) Unless a certification is renewed for a 3-year term as provided in this section,
14 the certification expires on the date the Secretary sets.

15 (c) At least 90 days before a certification expires, the applicant shall mail to the
16 Secretary:

17 (1) a renewal application form;

18 (2) the amount of the renewal fee; and

19 (3) the amount of any late fee, as determined by the Secretary.

20 (d) An individual periodically may renew the certification for an additional
21 3-year term, if the individual:

22 (1) otherwise is entitled to be certified;

23 (2) pays to the Secretary:

24 (i) a renewal fee of \$10;

25 (ii) payment for the cost of a fingerprint card record check by the
26 Federal Bureau of Investigation; and

27 (iii) any late fee required under this subtitle; [and]

1 (3) (I) SATISFACTORILY COMPLETES ~~10~~ 8 HOURS OF CONTINUING
2 SECURITY TRAINING THAT IS APPROVED BY THE MARYLAND POLICE TRAINING AND
3 STANDARDS COMMISSION UNDER § 19-412 OF THIS SUBTITLE; AND

4 (II) SUBMITS TO THE SECRETARY SUPPORTING
5 DOCUMENTATION THAT DEMONSTRATES COMPLETION OF THE TRAINING; AND

6 (4) submits to the Secretary a renewal application on the form that the
7 Secretary provides.

8 (e) (1) Subject to paragraph (2) of this subsection, if a complete application for
9 renewal of certification as required under this subtitle is not received by the Secretary on
10 or before the first business day of the next calendar month immediately following the
11 renewal date, the Secretary shall assess a late fee of \$5 per day until the application is
12 received by the Secretary.

13 (2) (i) The Secretary may not charge a late fee under paragraph (1) of
14 this subsection if the applicant did not make timely renewal because of incapacity,
15 hospitalization, being called to active military duty, or other hardship.

16 (ii) The total amount of late fees assessed against an applicant under
17 this subsection may not exceed \$150.

18 (3) The Secretary may not certify any applicant under this subtitle if the
19 applicant has outstanding late fee obligations.

20 (f) (1) The Secretary shall renew the certification of each individual who
21 meets the requirements of this section.

22 (2) Within 5 days after the Secretary refuses to renew the certification of
23 an individual as a security guard, the Secretary shall send written notice of the refusal to
24 the individual who submitted the renewal application.

25 (G) **AT LEAST 90 DAYS BEFORE A CERTIFICATION EXPIRES, THE LICENSED
26 SECURITY GUARD AGENCY OR SECURITY GUARD EMPLOYER SHALL SUBMIT A
27 DECLARATION TO THE SECRETARY UNDER THE PENALTIES OF PERJURY STATING
28 WHETHER IT KNOWS ~~OR HAS REASON TO KNOW~~ THAT A CERTIFIED SECURITY GUARD
29 WHO PROVIDES SECURITY GUARD SERVICES ON THE SECURITY GUARD AGENCY'S
30 BEHALF OR FOR THE SECURITY GUARD EMPLOYER NO LONGER SATISFIES ALL OF
31 THE CRITERIA FOR CERTIFICATION UNDER § 19-402 OF THIS SUBTITLE.**

32 19-407.

33 (a) Whenever a security guard is in uniform, the security guard may wear a badge
34 that is:

1 (1) of a design approved by the Secretary; and

2 (2) issued by the licensed security guard agency **OR THE SECURITY**
3 **GUARD EMPLOYER** that employs the security guard.

4 (b) Whenever a security guard is in uniform, the security guard shall clearly
5 display and wear the clearance card issued by the Secretary which identifies the security
6 guard.

7 19–408.

8 **(A)** Subject to the hearing provisions of § 19–410 of this subtitle, the Secretary
9 may deny certification as a security guard to any applicant, reprimand or fine any
10 individual certified as a security guard, or suspend, revoke, or refuse to renew the
11 certification of an individual:

12 (1) for any applicable ground under § 19–313 of this title;

13 (2) if the applicant or individual fraudulently or deceptively obtains or
14 attempts to obtain certification as a security guard for the applicant or individual or for
15 another;

16 (3) if the applicant or individual fails to maintain the standards set by the
17 Secretary for certification as a security guard; or

18 (4) if, under the laws of the United States or of any state, the applicant or
19 individual pleads guilty or nolo contendere to or is convicted of:

20 (i) a felony; or

21 (ii) a misdemeanor that is directly related to the fitness and
22 qualification of the applicant or individual to be certified as a security guard.

23 **(B) SUBJECT TO THE HEARING PROVISIONS OF § 19–410 OF THIS SUBTITLE,**
24 **THE SECRETARY SHALL DENY, REVOKE, OR REFUSE TO RENEW THE CERTIFICATION**
25 **OF A SECURITY GUARD WHO:**

26 **(1) HAS BEEN CONVICTED OF:**

27 **(I) A DISQUALIFYING CRIME UNDER § 5–101 OF THE PUBLIC**
28 **SAFETY ARTICLE; OR**

29 **(II) A CRIME OF VIOLENCE UNDER § 14–101 OF THE CRIMINAL**
30 **LAW ARTICLE;**

1 (2) HAS HAD ANY FORMAL FINDINGS BY A COURT, HEARING BOARD,
2 THE SECRETARY, OR OTHER GOVERNMENTAL ENTITY OF:

3 (I) UNLAWFUL OR EXCESSIVE USE OF FORCE; OR ~~OR~~

4 (II) MAKING A FALSE STATEMENT DURING THE SECURITY
5 GUARD'S EMPLOYMENT AS A POLICE OFFICER WITH A LAW ENFORCEMENT AGENCY;
6 OR

7 (3) HAS NOT SATISFACTORILY COMPLETED THE REQUIRED
8 CONTINUING SECURITY TRAINING UNDER § 19-404.1 OF THIS SUBTITLE.

9 (C) (1) A LICENSED SECURITY GUARD AGENCY OR SECURITY GUARD
10 EMPLOYER SHALL NOTIFY THE SECRETARY WITHIN 48 HOURS IF IT KNOWS ~~OR HAS~~
11 ~~REASON TO KNOW~~ THAT AN INDIVIDUAL WHO PROVIDES SECURITY GUARD SERVICES
12 ON ITS BEHALF OR FOR IT HAS BEEN ARRESTED FOR A CRIME OF VIOLENCE UNDER
13 § 14-101 OF THE CRIMINAL LAW ARTICLE OR A DISQUALIFYING CRIME UNDER §
14 5-101 OF THE PUBLIC SAFETY ARTICLE.

15 (2) SUBJECT TO § 10-226(C)(2) OF THE STATE GOVERNMENT
16 ARTICLE, THE SECRETARY MAY IMPOSE AN EMERGENCY SUSPENSION OF THE
17 CERTIFICATION OF A SECURITY GUARD WHO HAS BEEN ARRESTED FOR AN OFFENSE
18 UNDER PARAGRAPH (1) OF THIS SUBSECTION.

19 19-412.

20 (A) THE MARYLAND POLICE TRAINING AND STANDARDS COMMISSION
21 SHALL IDENTIFY INITIAL AND CONTINUING TRAINING PROGRAMS FOR SECURITY
22 GUARD CERTIFICATION AND RENEWAL OF CERTIFICATION, AS REQUIRED IN §§
23 19-402 AND 19-404.1 OF THIS SUBTITLE.

24 (B) THE TRAINING PROGRAMS UNDER SUBSECTION (A) OF THIS SECTION
25 SHALL INCLUDE TRAINING ON THE FOLLOWING:

26 (1) RELEVANT CRIMINAL LAW;

27 (2) THE APPROPRIATE USE OF FORCE;

28 (3) THE USE OF ALTERNATIVES TO FORCE;

29 (4) THE USE OF DE-ESCALATION TECHNIQUES; AND

30 (5) PROMOTING APPROPRIATE INTERACTIONS WITH INDIVIDUALS

31 WHO:

1 (I) ARE UNDER 18 YEARS OF AGE;

2 (II) HAVE BEHAVIORAL HEALTH OR OTHER DISABILITIES; OR

3 (III) ARE IN CRISIS.

4 (C) SUBJECT TO SUBSECTION (D) OF THIS SECTION, THE TRAINING
5 PROGRAMS IDENTIFIED BY THE MARYLAND POLICE TRAINING AND STANDARDS
6 COMMISSION UNDER SUBSECTION (A) OF THIS SECTION SHALL SATISFY THE
7 FOLLOWING TRAINING REQUIREMENTS:

8 (1) THE 12-HOUR INITIAL TRAINING REQUIREMENT UNDER § 19-402
9 OF THIS SUBTITLE; AND

10 (2) THE ~~10-HOUR~~ 8-HOUR CONTINUING SECURITY TRAINING UNDER
11 § 19-404.1 OF THIS SUBTITLE.

12 (D) IF THE MARYLAND POLICE TRAINING AND STANDARDS COMMISSION IS
13 UNABLE TO IDENTIFY AN INITIAL OR CONTINUING TRAINING PROGRAM UNDER
14 SUBSECTION (A) OF THIS SECTION, THE COMMISSION SHALL ESTABLISH AN INITIAL
15 OR CONTINUING TRAINING PROGRAM THAT MEETS THE REQUIREMENTS UNDER
16 SUBSECTION (B) OF THIS SECTION.

17 (E) THE MARYLAND POLICE TRAINING AND STANDARDS COMMISSION
18 SHALL PROMINENTLY PUBLISH THE LIST OF THE PROGRAMS IDENTIFIED UNDER
19 SUBSECTION (A) OF THIS SECTION OR ESTABLISHED BY THE COMMISSION UNDER
20 SUBSECTION (D) OF THIS SECTION ON THE COMMISSION'S WEBSITE.

22 (A) SUBJECT TO SUBSECTION (B) OF THIS SECTION, A SECURITY GUARD
23 MUST HOLD A VALID PERMIT TO CARRY A HANDGUN UNDER TITLE 5, SUBTITLE 3 OF
24 THE PUBLIC SAFETY ARTICLE BEFORE CARRYING A HANDGUN WHILE PROVIDING
25 SECURITY GUARD SERVICES.

26 (B) A SECURITY GUARD MAY NOT CARRY A HANDGUN WHILE PROVIDING
27 SECURITY GUARD SERVICES UNTIL:

28 (1) RECEIVING APPROVAL TO CARRY A HANDGUN FROM THE
29 LICENSED SECURITY GUARD AGENCY OR SECURITY GUARD EMPLOYER;

30 (2) NOTIFYING THE SECRETARY OF THE INTENT OF THE SECURITY
31 GUARD TO CARRY A HANDGUN WHILE PROVIDING SECURITY GUARD SERVICES; AND

1 **(3) THE SECRETARY CONFIRMS THAT THE SECURITY GUARD HAS A**
2 **VALID PERMIT TO CARRY A HANDGUN UNDER TITLE 5, SUBTITLE 3 OF THE PUBLIC**
3 **SAFETY ARTICLE AND HAS NOT BEEN CONVICTED OF A DISQUALIFYING CRIME**

6 **(A) (1) IN THIS SECTION, “USE OF FORCE” MEANS:**

7 **(I) ANY PHYSICAL STRIKING, ~~OR ATTEMPTED STRIKING,~~ OF AN**
8 **INDIVIDUAL;**

9 **(II) ANY SIGNIFICANT PHYSICAL CONTACT THAT RESTRICTS**
10 **THE MOVEMENT OF AN INDIVIDUAL, INCLUDING CONTROL TECHNIQUES; OR**

11 **(III) THE DETAINMENT OF AN INDIVIDUAL WITHOUT THE**
12 **INDIVIDUAL’S CONSENT.**

13 **(2) “USE OF FORCE” INCLUDES:**

14 **(I) THE DISCHARGE OF A FIREARM;**

15 **(II) THE DISCHARGE OF PEPPER MACE, AS DEFINED IN § 4-101**
16 **OF THE CRIMINAL LAW ARTICLE; AND**

17 **(III) THE USE OF AN ELECTRONIC CONTROL DEVICE, AS DEFINED**
18 **IN § 4-109 OF THE CRIMINAL LAW ARTICLE.**

19 **(3) “USE OF FORCE” DOES NOT INCLUDE MERE PRESENCE, VERBAL**
20 **COMMANDS, OR ESCORTING AN INDIVIDUAL WITH MINIMAL RESISTANCE.**

21 **(B) (1) SUBJECT TO PARAGRAPH (2) OF THIS SUBSECTION, A SECURITY**
22 **GUARD SHALL REPORT ANY USE OF FORCE AGAINST A PERSON WHILE PROVIDING**
23 **SECURITY GUARD SERVICES ON BEHALF OF THE LICENSED SECURITY GUARD**
24 **AGENCY OR FOR THE SECURITY GUARD EMPLOYER TO THE SECURITY GUARD**
25 **AGENCY OR THE SECURITY GUARD EMPLOYER WITHIN 48 HOURS AFTER THE USE OF**
26 **FORCE ON A FORM PROVIDED BY THE SECRETARY.**

27 **(2) A SECURITY GUARD IS NOT REQUIRED TO REPORT ANY USE OF**
28 **FORCE AGAINST A PERSON WITHIN 48 HOURS AFTER THE USE OF FORCE IF THE**
29 **SECURITY GUARD IS SERIOUSLY INJURED OR DISABLED.**

1 **(C) (1) A LICENSED SECURITY GUARD AGENCY OR SECURITY GUARD**
 2 **EMPLOYER SHALL, IN ACCORDANCE WITH PARAGRAPH (2) OF THIS SUBSECTION,**
 3 **REPORT ANY USE OF FORCE BY A SECURITY GUARD WHILE PROVIDING SECURITY**

11 **(III) THE LOCATION OF THE INCIDENT WHERE FORCE WAS USED;**

12 **(IV) WHETHER THE INDIVIDUAL AGAINST WHOM FORCE WAS**
 13 **USED WAS ARRESTED AND, IF KNOWN, WHAT CHARGES THE INDIVIDUAL RECEIVED;**

14 **(V) WHETHER THE INDIVIDUAL AGAINST WHOM FORCE WAS**
 15 **USED REQUESTED OR REQUIRED MEDICAL CARE;**

16 **(VI) WHETHER THE SECURITY GUARD REQUESTED OR**
 17 **REQUIRED MEDICAL CARE; ~~AND~~**

18 **(VII) DEMOGRAPHIC INFORMATION ABOUT ANY INDIVIDUALS**
 19 **AGAINST WHOM FORCE WAS USED AND ANY SECURITY GUARD INVOLVED IN THE**
 20 **INCIDENT, INCLUDING RACE, ETHNICITY, GENDER, AND AGE; AND**

21 **(VIII) THE FORM COMPLETED UNDER SUBSECTION (B)(1) OF THIS**

24 **(a) (1) A security guard agency OR SECURITY GUARD EMPLOYER that**
 25 **employs five or more individuals as security guards shall:**

26 **[(1)] (I) maintain commercial general liability insurance, including**
 27 **errors and omissions and completed operations with a \$1,000,000 total aggregate**
 28 **minimum; and**

29 **[(2)] (II) submit proof of the required insurance to the Secretary.**

30 **(2) A SECURITY GUARD AGENCY OR SECURITY GUARD EMPLOYER**
 31 **THAT EMPLOYS FEWER THAN FIVE INDIVIDUALS AS SECURITY GUARDS SHALL:**

1 **(I) MAINTAIN COMMERCIAL GENERAL LIABILITY INSURANCE,**
2 **INCLUDING ERRORS AND OMISSIONS AND COMPLETED OPERATIONS WITH A**
3 **\$500,000 TOTAL AGGREGATE MINIMUM; AND**

4 **(II) SUBMIT PROOF OF THE REQUIRED INSURANCE TO THE**
5 **SECRETARY.**

6 (b) (1) If an applicant for a license **OR A SECURITY GUARD EMPLOYER**
7 intends to employ [five] **ONE** or more individuals as security guards, the applicant shall
8 submit proof of the liability insurance required under subsection (a) of this section to the
9 Secretary with the license application.

10 (2) **(I)** The Secretary may not issue a license to an applicant to whom
11 the insurance requirements of this section would apply unless the applicant submits proof
12 of the insurance.

13 **(II) THE SECRETARY MAY NOT AUTHORIZE THE CERTIFICATION**
14 **OF A SECURITY GUARD FOR A SECURITY GUARD EMPLOYER UNLESS THE SECURITY**
15 **GUARD EMPLOYER SUBMITS PROOF OF APPLICABLE INSURANCE UNDER**
16 **SUBSECTION (A) OF THIS SECTION.**

17 (c) If the insurance required for a security guard agency **OR SECURITY GUARD**
18 **EMPLOYER** under this section is canceled, forfeited, or otherwise terminated, both the
19 security guard agency **OR THE SECURITY GUARD EMPLOYER** and the insurer shall notify
20 the Secretary.

21 (d) If a security guard agency fails to maintain the liability insurance required
22 under this section, the license of the security guard agency:

23 (1) is suspended automatically;

24 (2) shall remain suspended until the agency complies with the
25 requirements; and

26 (3) may not be reinstated until the agency submits proof of the required
27 insurance to the Secretary.

28 **(E) IF A SECURITY GUARD EMPLOYER FAILS TO MAINTAIN THE LIABILITY**
29 **INSURANCE REQUIRED UNDER THIS SECTION, THE SECRETARY MAY PROHIBIT A**
30 **SECURITY GUARD EMPLOYER FROM EMPLOYING A CERTIFIED SECURITY GUARD**
31 **UNTIL THE SECURITY GUARD EMPLOYER:**

32 **(1) COMPLIES WITH THE APPLICABLE INSURANCE REQUIREMENTS**
33 **UNDER SUBSECTION (A) OF THIS SECTION; AND**

1 **(2) SUBMITS PROOF OF THE REQUIRED INSURANCE TO THE**
2 **SECRETARY.**

4 1, 2024.
