A BILL ENTITLED

1 AN ACT concerning

2 **Capital Funding – Deferred Maintenance – Reporting Requirements**

3 FOR the purpose of requiring certain entities that receive in a prior fiscal year a certain
4 amount of State capital funding for certain facilities to submit a report on deferred
5 maintenance; requiring certain entities to report to certain committees of the
6 General Assembly on or before a certain date; requiring the report to include certain
7 information; defining certain terms; and generally relating to a report on deferred
8 maintenance.

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
15 That the Laws of Maryland read as follows:

16 **Article – State Finance and Procurement**

17 **8–304.**

18 (A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS
19 INDICATED.

20 (2) “CONVENTION FACILITY” HAS THE MEANING STATED IN § 10–601
21 OF THE ECONOMIC DEVELOPMENT ARTICLE.

22 (3) “INSTITUTION OF HIGHER EDUCATION” HAS THE MEANING
23 STATED IN § 10–101 OF THE EDUCATION ARTICLE.

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.



1 **(B) THIS SECTION APPLIES TO A CONVENTION FACILITY AND A FACILITY AT**
2 **AN INSTITUTION OF HIGHER EDUCATION THAT RECEIVES STATE CAPITAL FUNDING**
3 **TOTALING AT LEAST \$2,000,000 IN THE OPERATING OR CAPITAL BUDGET BILLS IN**
4 **THE PRIOR FISCAL YEAR.**

5 **(C) SUBJECT TO SUBSECTION (D) OF THIS SECTION, ON OR BEFORE**
6 **OCTOBER 1 EACH YEAR, THE ENTITY RESPONSIBLE FOR FACILITIES MAINTENANCE**
7 **FOR A FACILITY SPECIFIED IN SUBSECTION (B) OF THIS SECTION SHALL SUBMIT A**
8 **REPORT IN ACCORDANCE WITH § 2-1257 OF THE STATE GOVERNMENT ARTICLE TO**
9 **THE SENATE BUDGET AND TAXATION COMMITTEE AND THE HOUSE**
10 **APPROPRIATIONS COMMITTEE ON THE ENTITY'S DEFERRED MAINTENANCE PLAN.**

11 **(D) THE REPORT REQUIRED UNDER SUBSECTION (C) OF THIS SECTION**
12 **SHALL INCLUDE:**

13 **(1) THE DOLLAR AMOUNT THAT THE ENTITY SPENDS PER SQUARE**
14 **FOOT ON DEFERRED MAINTENANCE;**

15 **(2) THE TOTAL DOLLAR VALUE OF THE BACKLOG FOR DEFERRED**
16 **MAINTENANCE;**

17 **(3) THE PROCESS FOR FACILITY CONDITION ASSESSMENT,**
18 **INCLUDING THE PROCESS FOR RATING AND ASSESSING DEFERRED MAINTENANCE**
19 **PROJECTS;**

20 **(4) THE NUMBER OF STAFF HOURS DEVOTED TO INSPECTING AND**
21 **ANALYZING THE NEED FOR FACILITY REPAIR AND MAINTENANCE; AND**

22 **(5) THE ENTITY'S PLAN TO ADDRESS ALL DEFERRED MAINTENANCE**
23 **PROJECTS.**

24 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
25 1, 2020.
