A BILL ENTITLED

1 AN ACT concerning

2 **Public Health – Healthy Maryland Program – Establishment**

3 FOR the purpose of establishing the Healthy Maryland Program as a public corporation
4 and a unit of State government; providing that the exercise by Healthy Maryland of
5 its authority under this Act is an essential government function; stating the findings
6 and intent of the General Assembly; providing for the construction and effect of this
7 Act; prohibiting Healthy Maryland and certain agencies and employees from
8 providing or disclosing certain information for certain purposes; prohibiting certain
9 law enforcement agencies from using certain funds, facilities, property, equipment,
10 and personnel to investigate, enforce, or assist in the investigation or enforcement of
11 certain violations and warrants; providing for the duties of Healthy Maryland;
12 establishing that Healthy Maryland is subject to certain provisions of law;
13 establishing the Healthy Maryland Board; providing for the duties of Board
14 members; establishing certain requirements and prohibitions for Board members
15 regarding conflicts of interest; prohibiting a member of the Board from being held
16 personally liable for certain actions taken as a member; establishing the powers and
17 duties of the Board; requiring the Board to appoint an Executive Director of Healthy
18 Maryland; establishing the powers and duties of the Executive Director; requiring
19 the Secretary of Budget and Management to perform certain functions relating to
20 the employment and contracting of staff for Healthy Maryland; providing that an
21 employee or independent contractor of Healthy Maryland is not subject to certain
22 laws, regulations, or executive orders; providing for the implementation of Healthy
23 Maryland; requiring the Board to provide a certain percentage of the annual budget
24 of Healthy Maryland to provide certain assistance to certain programs for a certain
25 time period; prohibiting a carrier from offering certain benefits and certain services;
26 authorizing certain carriers to offer certain benefits requiring that certain data be
27 reported to the Maryland Health Services Cost Review Commission; providing that

1 a certain provision of law does not impact certain provider reporting requirements;
2 establishing the Healthy Maryland Public Advisory Committee; establishing certain
3 requirements and prohibitions for Advisory Committee members regarding conflicts
4 of interest; establishing the powers and duties of the Advisory Committee;
5 prohibiting a member of the Advisory Committee from being held personally liable
6 for certain actions taken as a member; establishing certain eligibility standards for
7 enrollment in Healthy Maryland; prohibiting certain participating providers from
8 engaging in certain conduct; authorizing certain institutions of higher education to
9 purchase certain coverage for certain individuals; establishing certain requirements
10 for certain employers and certain employees relating to the payment of certain
11 premiums; authorizing certain residents of the State to receive certain benefits
12 through certain employers and to opt out of participation in Healthy Maryland;
13 providing that certain contributions made by employers on behalf of certain
14 employees may not be abridged by this Act; authorizing certain persons to take
15 certain credits against certain premiums; providing for the distribution, application,
16 and amount of the credits; establishing the benefits covered under Healthy
17 Maryland; establishing that a certain physician or health care provider has a certain
18 approval under certain provisions of this Act and is authorized to establish a certain
19 diagnosis and assessment; requiring the Board to perform a certain evaluation in a
20 certain manner; authorizing health care providers and members of Healthy
21 Maryland to petition the Board for a certain purpose; providing for the manner in
22 which long-term services and supports are to be provided under Healthy Maryland;
23 establishing certain qualifications and requirements that must be met for health
24 care providers to participate in Healthy Maryland; authorizing and requiring
25 participating providers to provide certain services and take certain actions under
26 Healthy Maryland; authorizing a member of Healthy Maryland to receive certain
27 services from certain health care providers under certain circumstances; providing
28 for the enrollment with and withdrawal from certain health care delivery systems,
29 medical practices, and community providers for certain individuals and members of
30 Healthy Maryland; prohibiting certain entities from furnishing certain items and
31 services under certain circumstances; prohibiting participating providers from
32 taking certain actions; requiring that a certain contract contain certain provisions;
33 providing that a certain contract is null and void; prohibiting certain payments
34 under certain circumstances; prohibiting the Board from terminating a certain
35 participation agreement or from certain discrimination against certain individuals
36 under certain circumstances; authorizing a certain provider or authorized
37 representative of a provider to seek certain relief; prohibiting a certain employer
38 from terminating or otherwise discriminating against a certain employee under
39 certain circumstances; authorizing a certain employee to file a certain civil action;
40 providing that certain rights, privileges, and remedies may not be waived under
41 certain circumstances; establishing certain requirements for the payment of certain
42 services under Healthy Maryland; prohibiting participating providers from charging
43 certain rates and soliciting or accepting certain payment from certain persons for
44 certain health care services; establishing certain requirements for payment of
45 certain capital-related expenses; requiring the Board to pay a certain global budget
46 payment to a certain provider within a certain time period; prohibiting certain
47 payment amounts from taking into account certain factors; allowing certain

1 operating expenses of a certain provider to include certain costs; requiring Healthy
2 Maryland to engage in certain negotiations with certain representatives; requiring
3 the Board to establish a certain formulary; requiring the Board to establish certain
4 rates; prohibiting certain payments from taking into account, allowing, or including
5 any process for the provision of certain funding; requiring Healthy Maryland to have
6 a certain standard of health care for residents of the State; prohibiting certain
7 payments under Healthy Maryland from being calculated in a certain manner;
8 establishing certain requirements and duties for health care providers who
9 participate in Healthy Maryland; requiring the Board, on or before a certain date, to
10 apply for certain waivers of certain requirements and make certain arrangements
11 under certain programs for a certain purpose; authorizing the Board to take certain
12 actions relating to certain implementation for Healthy Maryland and certain
13 administration of Medicare in the State; establishing certain requirements for
14 Healthy Maryland regarding certain supplemental insurance coverage and certain
15 drug coverage; authorizing the Board to waive or modify the applicability of certain
16 provisions of this Act under certain circumstances; authorizing the Board to apply
17 for coverage for certain members of Healthy Maryland and enroll those members in
18 certain programs; requiring certain members of Healthy Maryland to enroll in
19 certain coverage as a condition of certain eligibility for certain health care services;
20 requiring members of Healthy Maryland to provide and authorize Healthy Maryland
21 to obtain certain information; authorizing the termination of coverage under Healthy
22 Maryland under certain circumstances; requiring Healthy Maryland to assume
23 responsibility for providing certain benefits and certain health care services in a
24 certain manner; establishing the Healthy Maryland Trust Fund as a special,
25 nonlapsing fund; authorizing certain health care providers to meet and communicate
26 for the purpose of collectively negotiating with Healthy Maryland on certain matters;
27 establishing certain rights and requirements relating to certain negotiations with
28 Healthy Maryland; requiring a certain representative to pay a certain fee to the
29 Board for a certain purpose; requiring the Board to set the fee at a certain amount;
30 prohibiting certain concerted action and the negotiation of certain agreements by
31 certain representatives; repealing the Board of Trustees of the Maryland Health
32 Benefit Exchange; requiring the Healthy Maryland Board to oversee the
33 administration of the Maryland Health Benefit Exchange under certain
34 circumstances; repealing a requirement that the Board of Trustees of the Maryland
35 Health Benefit Exchange appoint an Executive Director of the Exchange, with the
36 approval of the Governor, and determine certain compensation for the Executive
37 Director; requiring the Executive Director of Healthy Maryland to serve as the
38 Executive Director of the Maryland Health Benefit Exchange under certain
39 circumstances; making the provisions of this Act severable; defining certain terms;

5 INJURY, A CONDITION, A DISEASE, OR ITS SYMPTOMS; AND

6 (2) THAT MEET ACCEPTED STANDARDS OF CARE AS DETERMINED BY
7 A PATIENT'S TREATING PHYSICIAN OR OTHER INDIVIDUAL HEALTH CARE PROVIDER
8 WHO, ACCORDING TO THAT HEALTH CARE PROVIDER'S SCOPE OF PRACTICE AND
9 LICENSURE IN THE STATE, IS AUTHORIZED TO ESTABLISH A MEDICAL DIAGNOSIS
10 AND HAS MADE A MEDICAL ASSESSMENT OF THE PATIENT'S CONDITION.

11 (U) "MEDICARE" MEANS TITLE XVIII OF THE SOCIAL SECURITY ACT AND
12 THE PROGRAMS THEREUNDER.

13 (V) "MEMBER" MEANS AN INDIVIDUAL WHO IS ENROLLED IN HEALTHY
14 MARYLAND.

15 (W) "OUT-OF-STATE HEALTH CARE SERVICE" MEANS A HEALTH CARE
16 SERVICE PROVIDED IN PERSON TO A MEMBER WHILE THE MEMBER IS TEMPORARILY
17 AND PHYSICALLY LOCATED OUTSIDE THE STATE BECAUSE:

18 (1) IT IS MEDICALLY NECESSARY THAT THE HEALTH CARE SERVICE
19 BE PROVIDED WHILE THE MEMBER PHYSICALLY IS OUTSIDE THE STATE; OR

30 INDIVIDUAL'S IMMIGRATION STATUS:

1 **(1) WHOSE PRIMARY PLACE OF ABODE IS IN THE STATE; AND**

2 **(2) WHO MEETS THE STATE RESIDENCE REQUIREMENTS ADOPTED BY**
3 **THE BOARD UNDER § 25-304(B) OF THIS TITLE.**

4 **(AA) “TEMPORARILY” MEANS FOR A PERIOD OF TIME THAT IS NOT MORE**
5 **THAN 90 DAYS.**

7 **(A) THE GENERAL ASSEMBLY FINDS THAT:**

8 **(1) ALL RESIDENTS OF THE STATE HAVE THE RIGHT TO HEALTH**
9 **CARE;**

10 **(2) RESIDENTS OF THE STATE, AS INDIVIDUALS, EMPLOYERS, AND**
11 **TAXPAYERS, HAVE EXPERIENCED:**

12 **(I) A RISE IN THE COST OF HEALTH CARE AND HEALTH CARE**
13 **COVERAGE IN RECENT YEARS, INCLUDING RISING PREMIUMS, DEDUCTIBLES, AND**
14 **COPAYS; AND**

15 **(II) RESTRICTED PROVIDER NETWORKS AND HIGH**
16 **OUT-OF-NETWORK CHARGES;**

17 **(3) BUSINESSES HAVE EXPERIENCED INCREASES IN THE COSTS OF**
18 **HEALTH CARE BENEFITS FOR EMPLOYEES, AND MANY EMPLOYERS ARE SHIFTING A**
19 **LARGER SHARE OF THE COST OF COVERAGE TO EMPLOYEES OR DROPPING**
20 **COVERAGE ENTIRELY;**

21 **(4) INDIVIDUALS OFTEN FIND THAT THE INDIVIDUALS ARE DEPRIVED**
22 **OF AFFORDABLE CARE AND CHOICE BECAUSE OF DECISIONS BY HEALTH BENEFIT**
23 **PLANS GUIDED BY THE PLAN’S ECONOMIC NEEDS RATHER THAN INDIVIDUALS’**
24 **HEALTH CARE NEEDS;**

25 **(5) TO ADDRESS THE FISCAL CRISIS FACING THE STATE AND ENSURE**
26 **THAT RESIDENTS OF THE STATE MAY EXERCISE THE RESIDENTS’ RIGHT TO HEALTH**
27 **CARE, COMPREHENSIVE HEALTH CARE COVERAGE NEEDS TO BE PROVIDED;**

28 **(6) PROFIT-MAKING HEALTH CARE PROVIDERS HAVE INCREASINGLY**
29 **DEVASTATED THE LIVES OF THOUSANDS OF MARYLAND RESIDENTS; AND**

1 **(7) MILLIONS OF DOLLARS THAT COULD BE SPENT ON CARE TO**
2 **MARYLAND RESIDENTS ARE DIVERTED TO PROFIT OR ARE WASTED ON**
3 **ADMINISTRATIVE COSTS NECESSARY IN A MULTI-PAYER HEALTH CARE SYSTEM.**

4 **(B) IT IS THE INTENT OF THE GENERAL ASSEMBLY THAT:**

5 **(1) THERE BE A COMPREHENSIVE UNIVERSAL SINGLE-PAYER**
6 **HEALTH CARE COVERAGE PROGRAM AND A HEALTH CARE COST CONTROL SYSTEM**
7 **FOR THE BENEFIT OF ALL RESIDENTS OF THE STATE;**

8 **(2) HEALTHY MARYLAND BE ESTABLISHED TO PROVIDE**
9 **COMPREHENSIVE UNIVERSAL HEALTH COVERAGE FOR EVERY MARYLAND**

20 the application thereof to any person or circumstance is held invalid for any reason in a
21 court of competent jurisdiction, the invalidity does not affect other provisions or any other
22 application of this Act that can be given effect without the invalid provision or application,
23 and for this purpose the provisions of this Act are declared severable.

24 SECTION 4. AND BE IT FURTHER ENACTED, That this Act shall take effect July
25 1, 2019.
