- 4 (II) FIVE MEMBERS APPOINTED BY THE PRESIDENT OF THE

- 12 (Q) ANY AGENCY OR UNIT OF STATE GOVERNMENT SHALL RESPOND TO A

- 15 (R) THE COMMISSION MAY CONTRACT WITH A VENDOR TO MAINTAIN A
 16 WHOLE-REGION VIRTUAL NOISE MONITORING SYSTEM TO ASSIST THE COMMISSION
 17 IN GATHERING DATA TO SUPPORT RESEARCH PROJECTS AND POLICY
 18 RECOMMENDATIONS.
- 19 (S) ON OR BEFORE JANUARY 1 EACH YEAR, THE COMMISSION SHALL 20 SUBMIT A REPORT ON THE COMMISSION'S ACTIVITIES, IN ACCORDANCE WITH \$ 2–1257 OF THE STATE GOVERNMENT ARTICLE, TO THE SENATE EDUCATION, 22 HEALTH, AND ENVIRONMENTAL AFFAIRS COMMITTEE AND THE HOUSE 23 ENVIRONMENT AND TRANSPORTATION COMMITTEE.
- SECTION 2. AND BE IT FURTHER ENACTED, That, for each of fiscal years 2024 through 2027, the Governor shall include in the annual budget bill an appropriation of at least \$430,000 to the Maryland Aviation Infrastructure Impacts Commission.
- SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2022. It shall remain effective for a period of 5 years and, at the end of July 1, 2027, this Act, with no further action required by the General Assembly, shall be abrogated and of no further force and effect.
