Motor Vehicle Registration - Exception for Golf Carts - City of Crisfield

- 3 FOR the purpose of creating an exception from motor vehicle registration requirements under certain circumstances for golf carts in the City of Crisfield; 4 5 providing that a person who operates a golf cart on a highway in the City of 6 Crisfield may operate the golf cart only on certain roads at certain times and 7 only if the golf cart is equipped with certain lighting devices; requiring a person 8 who operates a golf cart on a highway in the City of Crisfield to keep as far to 9 the right of the roadway as feasible; and generally relating to an exception to motor vehicle registration requirements for golf carts in the City of Crisfield. 10

14 15 16	A PERSON WHO OPERATES A GOLF CART ON A HIGHWAY IN THE CITY OF CRISFIELD, SOMERSET COUNTY WITHOUT REGISTRATION AS AUTHORIZED UNDER § 13–402(C)(12) OF THIS ARTICLE:
17	(1) MAY OPERATE THE GOLF CART ONLY:
18 19	(I) ON A HIGHWAY ON WHICH THE MAXIMUM POSTED SPEED LIMIT DOES NOT EXCEED 35 MILES PER HOUR;
