- 17 (A) IN THIS SECTION, "COMMUNITY-BASED HEALTH FAIR" MEANS AN EVENT
- 18 THAT OFFERS HEALTH CARE SERVICES TO AN INDIVIDUAL FOR FREE OR USING A
- 19 SLIDING FEE SCALE THAT IS SPONSORED BY:
- 20 (1) THE FEDERAL GOVERNMENT, THE STATE, OR A LOCAL
- 21 GOVERNMENT;
- 22 (2) A NONPROFIT ORGANIZATION THAT IS EXEMPT FROM TAXATION
- 23 UNDER § 501(C)(3) OF THE INTERNAL REVENUE CODE; OR
