- 3 FOR the purpose of altering the definition of "police officer" and "law enforcement officer" under certain provisions of law; clarifying that the terms "police officer" and "law 4 5 enforcement officer" include members of the Maryland Capitol Police of the 6 Department of General Services; clarifying the description of the geographic area 7 around certain multiservice centers over which the Department of General Services 8 has police jurisdiction; specifying that the police and security force established by 9 the Secretary of General Services is the Maryland Capitol Police of the Department 10 of General Services; altering the circumstances under which a member of a certain police and security force may be transferred from one facility to another facility; 11 providing for the application of certain provisions of law; and generally relating to 12 the Maryland Capitol Police of the Department of General Services. 13

- 11 (a) (1) In accordance with the provisions of the State Personnel and Pensions
 12 Article, the Secretary may establish a police and security force, TO BE KNOWN AS THE
 13 MARYLAND CAPITOL POLICE OF THE DEPARTMENT OF GENERAL SERVICES, to
 14 protect people and property on or about improvements, grounds, and multiservice centers
 15 under the jurisdiction of the Department, and in the surrounding areas of the buildings
 16 and grounds in Annapolis and Baltimore City as described in § 4–601(1) [and], (2), AND
 17 (3) of this subtitle.
- 18 (2) The police and security force may include sworn police officers.
- 19 (b) {A member of the police and security force may not be involuntarily
 20 transferred from a site to another site FROM ONE FACILITY TO ANOTHER FACILITY
 21 UNLESS THE CHIEF HAS FIRST GIVEN DUE CONSIDERATION TO PENDING
 22 APPLICATIONS FOR TRANSFER.
- 23 (c) A member of the police and security force has the same powers as a sheriff or 24 police officer under § 2–101 of the Criminal Procedure Article only if the member:

- 27 (2) is designated by the Department as a police officer.
