## 2 Labor and Employment – Private–Sector Employers – Right to Work

- FOR the purpose of prohibiting certain private-sector employers from requiring, as a
  condition of employment or continued employment, an employee or a prospective
  employee, under certain circumstances, to join or remain a member of a labor
  organization, pay charges to a labor organization, or pay a certain amount to a third
  party; and generally relating to the rights of individuals, employee organizations,
  and private-sector employers.

- 19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, 20 That the Laws of Maryland read as follows:

(a) In this section, "promise" means any undertaking, whether express or implied
 or oral or written.

1 (b) A promise made between an employee or prospective employee and an 2 employer, prospective employer, or any other individual, association, company, corporation, 3 or firm is against the policy of the State if the promise requires either party:

(1) to join or remain a member of an employer or labor organization;

5 (2) not to join or not to remain a member of an employer or labor 6 organization; or

7 (3) to withdraw from an employment relation if the party joins or remains 8 a member of an employer or labor organization.

9 [(c) A court may not grant, on the basis of a promise described in this section, any 10 relief against:

11 (1) a party to the promise; or

12 (2) another person who, without the act or threat of fraud or violence, 13 advises, induces, or urges a party to disregard the promise.]

18 **(B) (1)** "EMPLOYER" MEANS A PERSON ENGAGED IN A BUSINESS, AN 19 INDUSTRY, A PROFESSION, A TRADE, OR ANY OTHER ENTERPRISE IN THE STATE.

20 (2) "EMPLOYER" INCLUDES A PERSON THAT ACTS DIRECTLY OR 21 INDIRECTLY IN THE INTEREST OF ANOTHER EMPLOYER WITH AN EMPLOYEE.

5 (A) AN EMPLOYEE OR A PROSPECTIVE EMPLOYEE MAY FILE AN ACTION 6 AGAINST AN EMPLOYER FOR A VIOLATION OF § 4–703 OF THIS SUBTITLE IN THE 7 CIRCUIT COURT FOR THE JURISDICTION WHERE THE EMPLOYER IS LOCATED.

8 (B) IF AN EMPLOYER IS FOUND LIABLE FOR A VIOLATION OF § 4–703 OF THIS 9 SUBTITLE IN AN ACTION FILED UNDER SUBSECTION (A) OF THIS SECTION, THE 10 EMPLOYEE OR PROSPECTIVE EMPLOYEE WHO FILED THE ACTION IS ENTITLED TO 11 INJUNCTIVE RELIEF, DAMAGES, COURT COSTS, AND REASONABLE ATTORNEY'S 12 FEES.

24 (2) INVESTIGATE ALL COMPLAINTS REGARDING VIOLATIONS OF § 25 4–703 OF THIS SUBTITLE; AND

26 (3) COMMENCE AND TRY ALL PROSECUTIONS FOR VIOLATIONS OF § 27 4–703 OF THIS SUBTITLE.

#### 1 RESPECT TO CRIMINAL PROSECUTIONS.

2 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall be construed to 3 apply only prospectively and may not be applied or interpreted to have any effect on or 4 application to any collective bargaining agreement that is entered into before the effective 5 date of this Act.

6 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect 7 October 1, 2022.
