State Archivist - Process for Evaluating State Designations

3 FOR the purpose of altering the process by which the State Archivist reviews, evaluates, 4 and makes recommendations to the General Assembly regarding certain State 5 designations; providing that a certain provision of law does not affect the ability of 6 the General Assembly to enact certain legislation; requiring the State Archivist to 7 assist the General Assembly in reviewing and evaluating certain State designations in accordance with certain provisions of law; requiring the State Archivist to review 8 9 certain documentary evidence, establish a certain workgroup under certain 10 circumstances, and consider certain factors when reviewing and evaluating certain 11 State designations; requiring a certain member of the General Assembly who 12 sponsors certain legislation or otherwise makes a certain request to the State 13 Archivist to submit a certain statement and certain documentation to the State 14 Archivist; authorizing the State Archivist to contract for certain professional services 15 or reimburse certain workgroup members under certain circumstances; requiring 16 the State Archivist to submit certain reports to the General Assembly on or before 17 certain dates; requiring that certain reports include an evaluation of certain State 18 designations; making certain technical changes; defining a certain term; and 19 generally relating to the State Archivist and a process for evaluating State 20 designations.

- 9 (2) DOCUMENTATION OF THE STATE DESIGNATION INCLUDING:
- 10 (I) THE HISTORIC AND PRESENT DAY SIGNIFICANCE;
- 11 (II) THE RELEVANCE TO STATE CULTURE AND TRADITION;
- 12 (III) THE UNIQUENESS TO THE STATE; AND
- 13 (IV) THE INCLUSIVENESS OF ALL RESIDENTS OF THE STATE;

- 15 (3) ANY OTHER INFORMATION REQUESTED BY THE STATE
- 16 ARCHIVIST.
- 17 (F) SUBJECT TO THE LIMITATIONS OF THE STATE BUDGET, THE STATE
- 18 ARCHIVIST MAY CONTRACT FOR PROFESSIONAL SERVICES TO CARRY OUT THE
- 19 PROVISIONS OF THIS SECTION OR REIMBURSE WORKGROUP MEMBERS.
- 20 (G) (1) ON OR BEFORE DECEMBER 31, 2016, AND EACH DECEMBER 31
- 21 THEREAFTER, THE STATE ARCHIVIST SHALL SUBMIT A REPORT ON ITS FINDINGS,
- 22 INCLUDING ANY RECOMMENDATIONS, TO THE GENERAL ASSEMBLY, SUBJECT TO §
- 23 **2–1246** OF THIS ARTICLE.
- 24 (2) THE ANNUAL REPORT PREPARED BY THE STATE ARCHIVIST
- 25 SHALL INCLUDE AN EVALUATION OF ANY STATE DESIGNATION:
- 26 (I) LEGISLATIVELY PROPOSED DURING THE SESSION OF THE
- 27 GENERAL ASSEMBLY THAT YEAR; OR
- 28 (II) OTHERWISE SUBMITTED TO THE STATE ARCHIVIST FOR
- 29 REVIEW AND EVALUATION BY A MEMBER OF THE GENERAL ASSEMBLY BEFORE JULY
- 30 **1 THAT YEAR.**

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June 2 $\,$ 1, 2016.
