## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Transportation – Vehicle Parking Facilities – Motorcycle Parking**

3 FOR the purpose of requiring vehicle parking facilities that are owned, leased, or  
4 operated by the State or a political subdivision of the State or that receive  
5 funding from the State or a political subdivision of the State to allow  
6 motorcycles to park in the facilities, subject to certain charges; defining certain  
7 terms; and generally relating to the parking of motorcycles in vehicle parking  
8 facilities.

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
20 MARYLAND, That the Laws of Maryland read as follows:

3 (j) “Vehicle parking facility” means a controlled entrance and exit building,  
4 structure, surface lot, and other facility for parking vehicles, for which fees or charges  
5 are established for the use of the facility.

6 **26–301.1.**

7 (A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE  
8 MEANINGS INDICATED.

9 (2) “FUNDING” INCLUDES ANY FORM OF ASSURANCE,  
10 GUARANTEE, GRANT PAYMENT, CREDIT, TAX CREDIT, OR OTHER ASSISTANCE.

11 (3) “VEHICLE PARKING FACILITY” HAS THE MEANING STATED IN  
12 § 4–101 OF THIS ARTICLE.

13 (B) A VEHICLE PARKING FACILITY SHALL ALLOW MOTORCYCLES TO  
14 PARK IN THE FACILITY, SUBJECT TO THE CHARGES ESTABLISHED BY THE  
15 FACILITY, IF:

16 (1) THE FACILITY IS OWNED, OPERATED, OR LEASED BY THE  
17 STATE OR A POLITICAL SUBDIVISION OF THE STATE; OR

18 (2) THE FACILITY RECEIVES FUNDING FROM THE STATE OR A  
19 POLITICAL SUBDIVISION OF THE STATE.

20 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
21 July 1, 2011.
