4 FOR the purpose of establishing the Professional and Volunteer Firefighter Innovative 5 Cancer Screening Technologies Program; requiring the Maryland Department of 6 Health to administer the Program; authorizing the Department to adopt certain 7 regulations; providing for the purpose and goals of the Program; authorizing local fire departments and volunteer fire companies and departments to apply to the 8 9 Department for certain grants; requiring a county in which a volunteer fire company 10 or department is located to assist volunteer companies or departments in filing 11 certain applications; requiring the Department to issue a request for certain 12 applications for grants each year; specifying the contents of the application; 13 requiring the Department to develop a certain weighting formula; requiring the 14 Department to prioritize awarding grants to certain applicants; requiring the 15 Department to award the grants on a pro rata basis under certain circumstances; 16 requiring the Governor, for certain fiscal years, to include certain appropriations of 17 money in the annual budget bill for the Program; providing that certain 18 appropriations and expenditures are subject to audit by the Office of Legislative 19 Audits; requiring the Department to report to certain committees of the General 20 Assembly on or before a certain date each year; defining a certain term; and generally 21 relating to the Professional and Volunteer Firefighter Innovative Cancer Screening 22 Technologies Program.

- 3 (A) THE DEPARTMENT SHALL DEVELOP A WEIGHTING FORMULA BY WHICH 4 TO RATE EACH APPLICATION RECEIVED UNDER § 13–3904 OF THIS SUBTITLE.
- 5 (B) SUBJECT TO SUBSECTION (C) OF THIS SECTION, THE DEPARTMENT
 6 SHALL PRIORITIZE AWARDING GRANTS TO APPLICANTS BASED ON THE QUALITY OF
 7 THE APPLICATION AND THE DEGREE TO WHICH THE TESTS PROPOSED TO BE
 8 PROCURED BY THE APPLICANT MEET THE FOLLOWING CRITERIA:
- 9 (1) THE SCIENTIFIC AND CLINICAL EVIDENCE SUPPORTING THE 10 CLAIMED ACCURACY AND RELIABILITY OF THE TEST;
- 11 (2) WHETHER THE TEST EMPLOYS INNOVATIVE OR NOVEL 12 TECHNOLOGIES;
- 13 (3) THE ABILITY OF THE TEST TO SIMULTANEOUSLY SCREEN FOR 14 TWO OR MORE CANCER TYPES;
- 15 (4) THE COST-EFFECTIVENESS OF THE TEST; AND
- 16 (5) WHETHER THE TEST IS DEVELOPED, MANUFACTURED, OR COMMERCIALIZED BY A BUSINESS ENTITY LOCATED IN THE STATE.
- 18 (C) IF THE DEPARTMENT RECEIVES APPLICATIONS FOR GRANTS TOTALING
 19 MORE THAN THE AMOUNT OF FUNDS APPROPRIATED FOR THE PROGRAM FOR A
 20 FISCAL YEAR, THE DEPARTMENT SHALL AWARD THE GRANTS ON A PRO RATA BASIS.
