A BILL ENTITLED

1 AN ACT concerning

2 **Water Pollution Control – Discharge Permits – Industrial Poultry Operations**

3 FOR the purpose of prohibiting the Department of the Environment from issuing certain
4 discharge permits to a person for a certain new industrial poultry operation or for
5 the purpose of extending or expanding a certain industrial poultry operation;
6 defining certain terms; and generally relating to the discharge of pollutants into
7 waters of the State and industrial poultry operations.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
19 That the Laws of Maryland read as follows:

20 **Article – Environment**

21 9–323.

22 (a) (1) A person shall hold a discharge permit issued by the Department before
23 the person may construct, install, modify, extend, alter, or operate any of the following if

1 its operation could cause or increase the discharge of pollutants into the waters of this
2 State:

3 (i) An industrial, commercial, or recreational facility or disposal
4 system;

5 (ii) A State-owned treatment facility; or

6 (iii) Any other outlet or establishment.

7 (2) [A] **SUBJECT TO § 9-323.1 OF THIS SUBTITLE**, A person shall hold a
8 CAFO Discharge permit issued by the Department before the person may begin
9 construction on any part of a new CAFO.

10 (b) By rule or regulation, the Department may require a discharge permit for any
11 other activity.

12 (c) The Department may not issue a CAFO Discharge permit to a person that
13 violates subsection (a)(2) of this section.

15 (A) (1) **IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS**
16 **INDICATED.**

17 (2) **“DISCHARGE PERMIT” INCLUDES:**

18 (I) **A GENERAL DISCHARGE PERMIT FOR STORMWATER**
19 **ASSOCIATED WITH CONSTRUCTION ACTIVITY;**

20 (II) **A GENERAL DISCHARGE PERMIT FOR ANIMAL FEEDING**
21 **OPERATIONS; OR**

22 (III) **AN INDIVIDUAL NATIONAL POLLUTANT DISCHARGE**
23 **ELIMINATION SYSTEM PERMIT.**

24 (3) (I) **“INDUSTRIAL POULTRY OPERATION” MEANS AN ANIMAL**
25 **FEEDING OPERATION THAT PRODUCES 300,000 OR MORE BROILER CHICKENS PER**
26 **YEAR.**

27 (II) **“INDUSTRIAL POULTRY OPERATION” INCLUDES TWO OR**
28 **MORE POULTRY OPERATIONS IF:**

29 1. **THE DISTANCE BETWEEN THE POULTRY OPERATIONS**
30 **IS WITHIN 3 MILES; AND**

1 **2. THE POULTRY OPERATIONS ARE UNDER COMMON**
2 **OWNERSHIP OR CONTROL.**

3 **(B) THE DEPARTMENT MAY NOT ISSUE A DISCHARGE PERMIT TO A PERSON**
4 **FOR:**

5 **(1) A NEW INDUSTRIAL POULTRY OPERATION; OR**

6 **(2) THE PURPOSE OF EXTENDING OR EXPANDING ANY INDUSTRIAL**
7 **POULTRY OPERATION IN OPERATION ON OR BEFORE SEPTEMBER 30, 2020.**

8 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
9 October 1, 2020.
