A BILL ENTITLED

1 AN ACT concerning

2 **Baltimore City and Baltimore County – Child in Need of Supervision Pilot**
3 **Program – Increase, Allocation, and Extension**

4 FOR the purpose of increasing and allocating the General Fund appropriation for and
5 extending the termination date of the Child in Need of Supervision Pilot
6 Program in Baltimore City and Baltimore County; requiring the Governor to
7 include a certain General Fund appropriation in the budget bills for certain
8 fiscal years for a certain purpose; requiring that certain funds be provided as
9 grants to Baltimore County and Baltimore City for a certain purpose; and
10 generally relating to the Child in Need of Supervision Pilot Program in
11 Baltimore City and Baltimore County.

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
21 MARYLAND, That the Laws of Maryland read as follows:

22 **Chapter 601 of the Acts of 2005, as amended by Chapter 420 of the Acts of**
23 **2009**

1 SECTION 3. AND BE IT FURTHER ENACTED, That the Governor shall
2 include a general fund appropriation of \$250,000 for the Department of Juvenile
3 Services in each budget bill for fiscal 2007, fiscal 2008, fiscal 2009, fiscal 2010, fiscal
4 2011, fiscal 2012, and fiscal 2013 AND A GENERAL FUND APPROPRIATION OF
5 **\$300,000 FOR THE DEPARTMENT OF JUVENILE SERVICES IN EACH BUDGET**
6 **BILL FOR FISCAL 2015, FISCAL 2016, AND FISCAL 2017** for the purpose of
7 implementing the provisions of this Act. Of the ~~[\$250,000]~~ **\$300,000**, ~~[\$83,000]~~
8 **\$100,000** shall be provided as a grant to Baltimore County and ~~[\$167,000]~~ **\$200,000**
9 shall be provided as a grant to Baltimore City for the purpose of implementing the
10 provisions of this Act.

11 SECTION 4. AND BE IT FURTHER ENACTED, That Section 1 of this Act shall
12 take effect July 1, 2006.

13 SECTION 5. AND BE IT FURTHER ENACTED, That, except as provided in
14 Section 4 of this Act, this Act shall take effect October 1, 2005. It shall remain effective
15 until the end of ~~[June 30, 2013]~~ **JUNE 30, 2016**, and, at the end of ~~[June 30, 2013]~~
16 **JUNE 30, 2016**, with no further action required by the General Assembly, this Act
17 shall be abrogated and of no further force and effect.

18 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
19 June 1, 2013.
