## 1 (III) INCREASED BY 2% EACH YEAR FOR CALENDAR YEARS 2 2016, 2017, AND 2018; AND

# 3 (IV) EQUAL to the salary of a captain in the Anne Arundel 4 County Police Department at the highest rate in the pay scale FOR CALENDAR YEAR 5 2019 AND EACH SUBSEQUENT CALENDAR YEAR.

6 SECTION 2. AND BE IT FURTHER ENACTED, That, pursuant to Article III, § 7 35 of the Maryland Constitution, this Act may not be construed to extend or apply to 8 the salary or compensation of the Sheriff of Anne Arundel County while serving in a 9 term of office beginning before the effective date of this Act, but the provisions of this Act concerning the salary or compensation of the Sheriff of Anne Arundel County shall 10 take effect at the beginning of the next following term of office. This limitation does 11 not apply to an individual appointed or elected after the effective date of this Act to fill 1213out an unexpired term.

SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effectOctober 1, 2014.
