## **HOUSE BILL 1384**

- 1 **(A)** To provide for protection against fires, and to establish and to regulate all 2 matters relating to a Fire Department.
- 3 (B) (1) ON OR BEFORE JANUARY 1, 2017, THE FIRE DEPARTMENT SHALL
  4 DEVELOP A MEANS FOR A PRIVATE NONPROFIT AMBULANCE COMPANY WITH A BASE
  5 OF OPERATIONS IN THE CITY TO REGISTER AND OPERATE AS A VOLUNTEER RESCUE
