19	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
20	That the Laws of Maryland read as follows:
21	Article - Transportation
22	21–809.
23	(a) (1) In this section the following words have the meanings indicated.



- 1 (8) "Speed monitoring system" means a device with one or more motor vehicle sensors producing recorded images of motor vehicles traveling at speeds at least 12 miles per hour above the posted speed limit.
- 4 (b) (1) (i) A speed monitoring system may not be used in a local jurisdiction 5 under this section unless its use is authorized by the governing body of the local jurisdiction 6 by local law enacted after reasonable notice and a public hearing.
- 7 (vi) This section applies to a violation of this subtitle recorded by a 8 speed monitoring system that meets the requirements of this subsection and has been 9 placed:
- 1. In Montgomery County or Prince George's County, on a highway in a residential district, as defined in § 21–101 of this title, with a maximum posted speed limit of 35 miles per hour, which speed limit was established using generally accepted traffic engineering practices;
- 14 2. In a school zone with a posted speed limit of at least 20 miles per hour;
- 16 3. In Prince George's County:
- 17 A. Subject to subparagraph (vii)1 of this paragraph, on 18 Maryland Route 210 (Indian Head Highway); or
- B. On that part of a highway located within the grounds of an institution of higher education as defined in § 10–101(h) of the Education Article, or within one—half mile of the grounds of a building or property used by the institution of higher education where generally accepted traffic and engineering practices indicate that motor vehicle, pedestrian, or bicycle traffic is substantially generated or influenced by the institution of higher education;
- 25 4. Subject to subparagraph (vii)2 of this paragraph, on 26 Interstate 83 in Baltimore City; [or]
- 5. In Anne Arundel County, on Maryland Route 175 (Jessup Road) between the Maryland Route 175/295 interchange and the Anne Arundel County–Howard County line; **OR**
- 6. In Anne Arundel County, on Maryland Route G48 (Baltimore–Annapolis Boulevard) at the intersections with Cypress Creek Road and Brandywine Avenue.
- 33 (viii) Before activating a speed monitoring system, the local 34 jurisdiction shall:

- 3 1 Publish notice of the location of the speed monitoring 1. 2 system on its website and in a newspaper of general circulation in the jurisdiction; 3 2. Ensure that each sign that designates a school zone is 4 proximate to a sign that: 5 A. Indicates that speed monitoring systems are in use in the 6 school zone; and 7 Is in accordance with the manual for and the specifications В. 8 for a uniform system of traffic control devices adopted by the State Highway Administration under § 25–104 of this article; 9 10 3. With regard to a speed monitoring system established on 11 Maryland Route 210 (Indian Head Highway) in Prince George's County, based on proximity to an institution of higher education under subparagraph (vi)3 of this paragraph, on 12 13 Interstate 83 in Baltimore City, [or] in Anne Arundel County on Maryland Route 175 14 (Jessup Road) between the Maryland Route 175/295 interchange and the Anne Arundel County-Howard County line, OR IN ANNE ARUNDEL COUNTY ON MARYLAND ROUTE 15 648 (BALTIMORE-ANNAPOLIS BOULEVARD) AT THE INTERSECTIONS WITH 16 CYPRESS CREEK ROAD AND BRANDYWINE AVENUE, ensure that all speed limit signs 17 approaching and within the segment of highway on which the speed monitoring system is 18 19 located include signs that: 20 A. Are in accordance with the manual and specifications for 21a uniform system of traffic control devices adopted by the State Highway Administration 22 under § 25–104 of this article; and 23 B. Indicate that a speed monitoring system is in use; and 24 With regard to a speed monitoring system placed on 25Maryland Route 210 (Indian Head Highway) in Prince George's County, Interstate 83 in 26 Baltimore City, [or] in Anne Arundel County on Maryland Route 175 (Jessup Road) 27 between the Maryland Route 175/295 interchange and the Anne Arundel-Howard County 28 line. OR IN ANNE ARUNDEL COUNTY ON MARYLAND ROUTE 648 (BALTIMORE-ANNAPOLIS BOULEVARD) AT THE INTERSECTIONS WITH CYPRESS 29 CREEK ROAD AND BRANDYWINE AVENUE, ensure that each sign that indicates that a 30 31 speed monitoring system is in use is proximate to a device that displays a real-time posting
 - Unless the driver of the motor vehicle received a citation from a police officer at the time of the violation, the owner or, in accordance with subsection (f)(4) of this section, the driver of a motor vehicle is subject to a civil penalty if the motor vehicle is recorded by a speed monitoring system while being operated in violation of this subtitle.
