- 6 (4) THE OBSERVING ELECTION JUDGES SHALL MAINTAIN A RECORD 7 OF EACH USE OF CURBSIDE VOTING AT EACH CURBSIDE VOTING LOCATION.
- 8 (F) NOT LATER THAN 6 MONTHS BEFORE A PRIMARY ELECTION, THE STATE 9 BOARD, IN COLLABORATION WITH THE LOCAL BOARD IN EACH COUNTY, SHALL 10 DESIGNATE EACH CURBSIDE VOTING LOCATION IN THAT COUNTY.
- 11 (G) THE STATE BOARD SHALL ADOPT REGULATIONS TO CARRY OUT THIS 12 SECTION.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June 1, 2022.
