1 AN ACT concerning

2 **Howard County – Sheriff – Salary Increases**

3 **Ho. Co. 13–13**

4 FOR the purpose of increasing the annual salary of the Sheriff of Howard County to a
5 certain amount over a certain time period; making a certain technical correction
6 in a provision of law concerning the salary of the Sheriff for certain calendar
7 years; providing that this Act does not apply to the salary or compensation of
8 the incumbent Sheriff during a certain term of office; and generally relating to
9 the salary of the Sheriff of Howard County.

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
16 MARYLAND, That the Laws of Maryland read as follows:

17 **Article – Courts and Judicial Proceedings**

18 2–309.

1 (o) (1) (i) The Sheriff of Howard County shall receive an annual salary
2 as follows:

- 3 1. [\$65,000 for calendar year 2005;
4 2. \$66,500 for calendar year 2006;
5 3. \$77,500 for calendar year 2007;
6 4. \$80,000 for calendar year 2008;
7 5. \$82,500 for calendar year 2009; and
8 6.] \$85,000 EACH CALENDAR YEAR for calendar year
9 2010 THROUGH CALENDAR YEAR 2014;
- 10 2. \$88,000 FOR CALENDAR YEAR 2015;
11 3. \$91,000 FOR CALENDAR YEAR 2016;
12 4. \$94,000 FOR CALENDAR YEAR 2017; AND
13 5. \$97,000 FOR CALENDAR YEAR 2018.

14 SECTION 2. AND BE IT FURTHER ENACTED, That, pursuant to Article III, §
15 35 of the Maryland Constitution, this Act may not be construed to extend or apply to
16 the salary or compensation of the Sheriff of Howard County during a term of office
17 beginning before the effective date of this Act, but the provisions of this Act concerning
18 the salary or compensation of the Sheriff of Howard County shall take effect at the
19 beginning of the next following term of office.

20 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
21 October 1, 2013.
