A BILL ENTITLED

1 AN ACT concerning

2 **Corporations and Business Entities – Filing Fees and Combined Reporting**

3 FOR the purpose of prohibiting the State Department of Assessments and Taxation from
4 imposing a certain fee for the filing of certain documents by certain corporations and
5 business entities; requiring certain corporations to compute Maryland taxable
6 income using a certain method; authorizing certain corporations, subject to
7 regulations adopted by the Comptroller, to determine certain income using a certain
8 method; requiring, subject to regulations adopted by the Comptroller, certain groups
9 of corporations to file a combined income tax return reflecting the aggregate income
10 tax liability of all the members of the group; requiring the Comptroller to adopt
11 certain regulations; requiring certain regulations to be consistent with certain
12 regulations adopted by the Multistate Tax Commission; requiring the Comptroller
13 to report to the General Assembly on or before a certain date each year; defining
14 certain terms; providing for the application of certain provisions of this Act; and
15 generally relating to fees collected by the State Department of Assessments and
16 Taxation and the Maryland corporate income tax.

9 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
10 That the Laws of Maryland read as follows:

11 **Article – Corporations and Associations**

12 1-203.

13 (a) In addition to any organization and capitalization fee required under §
14 1-204 of this subtitle, subject to subsection (c) of this section, the Department shall collect
15 the fees specified in subsection (b) of this section.

16 (b) (3) (ii) **1. [For] EXCEPT AS PROVIDED UNDER SUBSUBPARAGRAPH**
17 **2 OF THIS SUBPARAGRAPH, FOR** each of the following documents which are filed but not
18 recorded, the filing fee is as indicated:

19 Annual report of a Maryland corporation, except a charitable or
20 benevolent institution, nonstock corporation, savings and loan corporation,
21 credit union, family farm, and banking institution..... \$300

22 Annual report of a foreign corporation subject to the jurisdiction of
23 this State, except a national banking association, savings and loan
24 association, credit union, nonstock corporation, and charitable and
25 benevolent institution..... \$300

26 Annual report of a Maryland savings and loan association, banking
27 institution, or credit union or of a foreign savings and loan association,
28 national banking association, or credit union that is subject to the
29 jurisdiction of this State \$300

30 Annual report of a Maryland limited liability company, limited
31 liability partnership, limited partnership, or of a foreign limited liability
32 company, foreign limited liability partnership, or foreign limited
33 partnership, except a family farm..... \$300

34 Annual report of a business trust..... \$300

35 Annual report of a real estate investment trust or foreign statutory

1 trust doing business in this State \$300

2 Annual report of a family farm..... \$100

3 **2. THE DEPARTMENT MAY NOT IMPOSE A FEE UNDER**
4 **SUBSUBPARAGRAPH 1 OF THIS SUBPARAGRAPH ON A CORPORATION OR BUSINESS**
5 **ENTITY WITH 10 OR FEWER EMPLOYEES.**

6 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland read
7 as follows:

8 **Article – Tax – General**

9 **10-402.1.**

10 **(A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS**
11 **INDICATED.**

12 **(2) “COMBINED GROUP” MEANS:**

13 **(I) ALL MEMBERS OF A UNITARY GROUP THAT ARE SUBJECT TO**
14 **THE INCOME TAX OR WOULD BE SUBJECT TO THE INCOME TAX IF DOING BUSINESS**
15 **IN THE STATE; AND**

16 **(II) OTHER MEMBERS OF THE UNITARY GROUP NOT DESCRIBED**
17 **IN ITEM (I) OF THIS PARAGRAPH UNDER THE CIRCUMSTANCES AND TO THE EXTENT**
18 **PROVIDED IN REGULATIONS ADOPTED BY THE COMPTROLLER TO PREVENT THE**
19 **AVOIDANCE OF TAX OR TO REFLECT CLEARLY THE INCOME OF ANY MEMBER OF THE**
20 **COMBINED GROUP FOR ANY PERIOD.**

21 **(3) “UNITARY GROUP” MEANS AN AFFILIATED GROUP OF**
22 **CORPORATIONS:**

23 **(I) THAT IS ENGAGED IN A UNITARY BUSINESS; AND**

24 **(II) OF WHICH MORE THAN 50% OF THE VOTING STOCK OF EACH**
25 **MEMBER IS DIRECTLY OR INDIRECTLY OWNED BY:**

26 **1. A COMMON OWNER OR COMMON OWNERS, EITHER**
27 **CORPORATE OR NONCORPORATE; OR**

28 **2. ONE OR MORE MEMBER CORPORATIONS OF THE**
29 **GROUP.**

1 **(B) THIS SECTION APPLIES ONLY TO A DOMESTIC OR FOREIGN**
2 **CORPORATION THAT:**

3 **(1) IS PRIMARILY ENGAGED IN ACTIVITIES THAT, IN ACCORDANCE**
4 **WITH THE NORTH AMERICAN INDUSTRIAL CLASSIFICATION SYSTEM (NAICS),**
5 **UNITED STATES MANUAL, UNITED STATES OFFICE OF MANAGEMENT AND**
6 **BUDGET, 2012 EDITION, WOULD BE INCLUDED IN SECTOR 44, 45, OR 722; AND**

7 **(2) MAINTAINS MULTIPLE LOCATIONS OF BUSINESS, WHETHER IN**
8 **THIS STATE OR ANOTHER STATE.**

9 **(C) WHETHER OR NOT THE COMBINED GROUP FILES A COMBINED INCOME**
10 **TAX RETURN UNDER § 10-811 OF THIS TITLE, A MEMBER OF A COMBINED GROUP**
11 **SHALL COMPUTE ITS MARYLAND TAXABLE INCOME USING THE COMBINED**
12 **REPORTING METHOD UNDER THIS SECTION.**

13 **(D) UNDER THE COMBINED REPORTING METHOD, IF A CORPORATION IS A**
14 **MEMBER OF A UNITARY GROUP AND IS SUBJECT TO THE MARYLAND INCOME TAX,**
15 **THE PART OF THE CORPORATION'S MARYLAND MODIFIED INCOME THAT IS DERIVED**
16 **FROM OR REASONABLY ATTRIBUTABLE TO TRADE OR BUSINESS CARRIED ON IN THE**
17 **STATE SHALL BE DETERMINED AS FOLLOWS:**

18 **(1) DETERMINE THE MARYLAND MODIFIED INCOME OF THE**
19 **COMBINED GROUP BY COMBINING THE CORPORATION'S INCOME WITH THE INCOME**
20 **OF OTHER MEMBERS OF THE COMBINED GROUP, DISREGARDING TRANSACTIONS**
21 **BETWEEN MEMBERS OF THE COMBINED GROUP TO REFLECT CLEARLY THE INCOME**
22 **OF THE COMBINED GROUP;**

23 **(2) DETERMINE THE PART OF THE COMBINED GROUP'S MARYLAND**
24 **MODIFIED INCOME THAT IS DERIVED FROM OR REASONABLY ATTRIBUTABLE TO**
25 **TRADE OR BUSINESS CARRIED ON IN THE STATE USING A MARYLAND**
26 **APPORTIONMENT FRACTION OF THE COMBINED GROUP BASED ON NUMERATORS**
27 **AND DENOMINATORS OF THE PROPERTY, PAYROLL, AND SALES FACTORS UNDER §**
28 **10-402 OF THIS SUBTITLE COMPUTED BY COMBINING THOSE AMOUNTS ASSOCIATED**
29 **WITH THE ACTIVITIES OF THE CORPORATION WITH THOSE AMOUNTS ASSOCIATED**
30 **WITH THE ACTIVITIES OF OTHER MEMBERS OF THE COMBINED GROUP,**
31 **DISREGARDING TRANSACTIONS BETWEEN MEMBERS OF THE COMBINED GROUP TO**
32 **REFLECT CLEARLY THE INCOME ALLOCABLE TO MARYLAND; AND**

33 **(3) FOR EACH MEMBER OF THE COMBINED GROUP THAT IS SUBJECT**
34 **TO THE MARYLAND INCOME TAX, ALLOCATE A PORTION OF THE AMOUNT**
35 **DETERMINED UNDER ITEM (2) OF THIS SUBSECTION TO THAT CORPORATION BY**
36 **MULTIPLYING THE AMOUNT DETERMINED UNDER ITEM (2) OF THIS SUBSECTION BY**
37 **A FRACTION:**

1 **(I) THE NUMERATOR OF WHICH IS THE MARYLAND**
2 **APPORTIONMENT FRACTION OF THAT CORPORATION, DETERMINED BY USING THAT**
3 **CORPORATION'S MARYLAND FACTORS IN THE NUMERATORS OF THE**
4 **APPORTIONMENT FORMULA AND USING THE COMBINED FACTORS OF ALL MEMBERS**
5 **OF THE COMBINED GROUP IN THE DENOMINATORS OF THE APPORTIONMENT**
6 **FORMULA; AND**

7 **(II) THE DENOMINATOR OF WHICH IS THE SUM OF THE**
8 **MARYLAND APPORTIONMENT FRACTIONS OF THE MEMBERS OF THE COMBINED**
9 **GROUP THAT ARE SUBJECT TO THE MARYLAND INCOME TAX.**

10 **(E) (1) SUBJECT TO REGULATIONS ADOPTED BY THE COMPTROLLER, A**
11 **CORPORATION THAT IS PART OF A COMBINED GROUP MAY ELECT TO DETERMINE ITS**
12 **INCOME DERIVED FROM OR ATTRIBUTABLE TO TRADE OR BUSINESS IN THE STATE**
13 **USING THE WATER'S EDGE METHOD AS DESCRIBED IN THIS SUBSECTION.**

14 **(2) UNDER THE WATER'S EDGE METHOD, THE COMBINED GROUP FOR**
15 **PURPOSES OF THE COMBINED REPORTING METHOD REQUIRED UNDER THIS**
16 **SECTION SHALL INCLUDE ONLY THE FOLLOWING AFFILIATED ENTITIES:**

17 **(I) CORPORATIONS THAT ARE INCORPORATED IN THE UNITED**
18 **STATES, EXCLUDING CORPORATIONS MAKING AN ELECTION UNDER §§ 931**
19 **THROUGH 936 OF THE INTERNAL REVENUE CODE;**

20 **(II) DOMESTIC INTERNATIONAL SALES CORPORATIONS, AS**
21 **DESCRIBED IN §§ 991 THROUGH 994 OF THE INTERNAL REVENUE CODE AND**
22 **FOREIGN SALES CORPORATIONS, AS DESCRIBED IN §§ 921 THROUGH 927 OF THE**
23 **INTERNAL REVENUE CODE;**

24 **(III) ANY CORPORATION OTHER THAN A BANK, REGARDLESS OF**
25 **THE PLACE WHERE IT IS INCORPORATED IF THE AVERAGE OF THE CORPORATION'S**
26 **PROPERTY, PAYROLL, AND SALES FACTORS WITHIN THE UNITED STATES IS 20% OR**
27 **MORE;**

28 **(IV) EXPORT TRADE CORPORATIONS, AS DESCRIBED IN §§ 970**
29 **THROUGH 972 OF THE INTERNAL REVENUE CODE;**

30 **(V) A FOREIGN CORPORATION DERIVING GAIN OR LOSS FROM**
31 **DISPOSITION OF AN INTEREST IN REAL PROPERTY IN THE UNITED STATES TO THE**
32 **EXTENT RECOGNIZED UNDER § 897 OF THE INTERNAL REVENUE CODE; AND**

33 **(VI) UNDER THE CIRCUMSTANCES AND TO THE EXTENT**
34 **PROVIDED BY REGULATIONS THAT THE COMPTROLLER ADOPTS:**

1 **1. A CORPORATION NOT DESCRIBED IN ITEMS (I)**
2 **THROUGH (V) OF THIS PARAGRAPH TO THE EXTENT OF ITS INCOME DERIVED FROM**
3 **OR ATTRIBUTABLE TO SOURCES WITHIN THE UNITED STATES AND ITS FACTORS**
4 **ASSIGNABLE TO A LOCATION WITHIN THE UNITED STATES; OR**

5 **2. AN AFFILIATED CORPORATION THAT IS A**
6 **CONTROLLED FOREIGN CORPORATION, AS DEFINED IN § 957 OF THE INTERNAL**
7 **REVENUE CODE.**

8 **(3) THE USE OF THE WATER’S EDGE METHOD IS SUBJECT TO THE**
9 **TERMS AND CONDITIONS THAT THE COMPTROLLER REQUIRES BY REGULATION,**
10 **INCLUDING ANY CONDITIONS THAT ARE NECESSARY OR APPROPRIATE TO PREVENT**
11 **THE AVOIDANCE OF TAX OR TO REFLECT CLEARLY THE INCOME FOR ANY PERIOD.**

12 **(F) (1) THE COMPTROLLER SHALL ADOPT REGULATIONS THAT ARE**
13 **NECESSARY AND APPROPRIATE TO CARRY OUT THIS SECTION.**

14 **(2) THE REGULATIONS ADOPTED BY THE COMPTROLLER SHALL BE**
15 **CONSISTENT WITH THE “PRINCIPLES FOR DETERMINING THE EXISTENCE OF A**
16 **UNITARY BUSINESS” (REG. IV.1.(B)) ADOPTED BY THE MULTISTATE TAX**
17 **COMMISSION.**

19 **ON OR BEFORE MARCH 31 OF EACH CALENDAR YEAR, THE COMPTROLLER**
20 **SHALL REPORT TO THE GENERAL ASSEMBLY, IN ACCORDANCE WITH § 2-1246 OF**
21 **THE STATE GOVERNMENT ARTICLE, AN ESTIMATE OF THE TOTAL ADDITIONAL TAX**
22 **REVENUE, IF ANY, THAT WILL BE COLLECTED FOR THE FISCAL YEAR THAT BEGINS**
23 **ON JULY 1 OF THAT CALENDAR YEAR AS A RESULT OF THE REQUIREMENT UNDER §**
24 **10-402.1 OF THIS SUBTITLE THAT MEMBERS OF CERTAIN COMBINED GROUPS**
25 **COMPUTE MARYLAND TAXABLE INCOME USING THE COMBINED REPORTING**
26 **METHOD.**

27 **10-811.**

28 **(A) [Each member of] EXCEPT AS PROVIDED BY AND SUBJECT TO**
29 **REGULATIONS ADOPTED BY THE COMPTROLLER, an affiliated group of corporations**
30 **[shall file a separate income tax return] ENGAGED IN A UNITARY BUSINESS SHALL FILE**
31 **A COMBINED INCOME TAX RETURN REFLECTING THE AGGREGATE INCOME TAX**
32 **LIABILITY OF ALL THE MEMBERS OF THE AFFILIATED GROUP THAT ARE ENGAGED IN**
33 **A UNITARY BUSINESS.**

1 **(B) THE COMPTROLLER SHALL ADOPT REGULATIONS THAT ARE**
2 **NECESSARY AND APPROPRIATE TO CARRY OUT THIS SECTION.**

3 SECTION 3. AND BE IT FURTHER ENACTED, That Section 2 of this Act shall be
4 applicable to all taxable years beginning after December 31, 2016.

5 SECTION 4. AND BE IT FURTHER ENACTED, That, subject to Section 3 of this
6 Act, this Act shall take effect July 1, 2016.
