1 AN ACT concerning

2 **Carroll County and Montgomery County – Gaming – Bingo Games**

3 **MC 13–18**

4 FOR the purpose of allowing, in Carroll County and Montgomery County, an individual
5 who is at least a certain age to conduct a bingo game involving cash prizes if the
6 game is conducted at a certain residential property in a certain manner; and
7 generally relating to gaming in Carroll County and Montgomery County.

8 BY adding to

9 Article – Criminal Law

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
14 That the Laws of Maryland read as follows:

15 **Article – Criminal Law**

16 13–1803.

17 **(C) NOTWITHSTANDING ANY OTHER PROVISION OF THIS SUBTITLE, IN**
18 **CARROLL COUNTY AND MONTGOMERY COUNTY, AN INDIVIDUAL WHO IS AT LEAST**
19 **21 YEARS OLD MAY CONDUCT A BINGO GAME INVOLVING CASH PRIZES IF THE GAME:**

1 **(1) IS CONDUCTED NOT MORE THAN ONCE A WEEK IN A COMMON AREA**
 2 **OF A RESIDENTIAL PROPERTY THAT IS RESTRICTED TO RESIDENTS WHO ARE AT**
 3 **LEAST 55 YEARS OLD;**

4 **(2) ALLOWS A PLAYER TO COMPETE DIRECTLY AGAINST ONE OR MORE**
 5 **OTHER PLAYERS WHO ARE RESIDENTS OF THE RESIDENTIAL PROPERTY WHERE THE**
 6 **GAME IS HELD;**

7 **(3) DOES NOT ALLOW AN INDIVIDUAL TO BENEFIT FINANCIALLY IN**
 8 **ANY WAY, DIRECTLY OR INDIRECTLY, OTHER THAN FROM THE WINNINGS ACCRUED**
 9 **BY PARTICIPATING AS A PLAYER IN THE GAME;**

10 **(4) DOES NOT INVOLVE:**

11 **(I) A PLAYER'S USE OF AN ELECTRONIC DEVICE THAT**
 12 **CONNECTS TO THE INTERNET;**

13 **(II) THE USE OF PAID PUBLIC ADVERTISING OR PROMOTIONS;**

14 **(III) THE CHARGING OF A FEE FOR ADMISSION, A SEAT,**
 15 **ENTERTAINMENT, OR ANY OTHER FEE; OR**

16 **(IV) THE USE OF ANY MONEY, EXCEPT MONEY USED FOR**
 17 **PURCHASING BINGO CARDS OR FOOD OR DRINK; AND**

18 **(5) HAS A LIMIT OF \$1,000 ON THE TOTAL AMOUNT OF MONEY,**
 19 **TOKENS REPRESENTING MONEY, OR ANY OTHER THING OR CONSIDERATION OF**
 20 **VALUE THAT MAY BE WON BY ALL PLAYERS DURING ANY 24-HOUR PERIOD.**

21 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
 22 1, 2018.
