21 22	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

- 1 (b) "Automotive repair facility" means any person who [diagnoses], FOR 2 FINANCIAL PROFIT:
- 3 (1) DIAGNOSES or corrects malfunctions of a motor vehicle [for financial 4 profit]; OR
- 5 (2) REPAIRS OR REPLACES AUTOMOTIVE GLASS.
- 6 (c) "Motor vehicle" has the meaning stated in Title 11 of the Transportation 7 Article.
- 8 (d) "Person" includes an individual, corporation, business trust, statutory trust, 9 estate, trust, partnership, association, two or more persons having a joint or common 10 interest, or any other legal or commercial entity.

- 12 (A) IN THIS SECTION, "ADVANCED DRIVER ASSISTANCE SYSTEM" MEANS AN
- 13 ELECTRONIC SAFETY SYSTEM THAT IS DESIGNED TO SUPPORT A DRIVER OPERATING
- 14 A MOTOR VEHICLE THAT IS INTENDED TO INCREASE VEHICLE SAFETY AND REDUCE
- 15 LOSSES ASSOCIATED WITH MOTOR VEHICLE CRASHES.
- 16 (B) BEFORE REPAIRING OR REPLACING AUTOMOTIVE GLASS, IF A MOTOR
- 17 VEHICLE IS EQUIPPED WITH AN ADVANCED DRIVER ASSISTANCE SYSTEM, AN
- 18 AUTOMOTIVE REPAIR FACILITY SHALL:
- 19 (1) Inform the customer if the recalibration of an 20 Advanced driver assistance system is required; and
- 21 (2) PROVIDE THE CUSTOMER WITH:
- 22 (I) AN ITEMIZED DESCRIPTION OF THE WORK TO BE 23 PERFORMED ON THE MOTOR VEHICLE; AND
- 24 (II) IF AN INSURER IS PAYING FOR ALL OR A PORTION OF THE
- 25 GLASS REPAIR, GLASS REPLACEMENT, OR THE RECALIBRATION OF AN ADVANCED
- 26 DRIVER ASSISTANCE SYSTEM, THE TOTAL AMOUNT THAT THE INSURER AGREES TO
- 27 PAY.
- 28 (C) AN AUTOMOTIVE REPAIR FACILITY MAY NOT REPRESENT TO A 29 CUSTOMER THAT THE COST OF WORK TO BE PERFORMED TO RECALIBRATE AN
- 30 ADVANCED DRIVER ASSISTANCE SYSTEM ON A MOTOR VEHICLE WILL BE PAID
- 50 ADVANCED DRIVER ASSISTANCE SYSTEM ON A MOTOR VEHICLE WILL BE PAID
- 31 ENTIRELY BY THE CUSTOMER'S INSURER AT NO COST TO THE CUSTOMER UNLESS

- 1 THE COST IS FULLY COVERED AND APPROVED BY THE INSURER.
- 2 (D) AN INSURER MAY NOT BE REQUIRED TO PAY MORE THAN A FAIR AND
- 3 COMPETITIVE PRICE FOR THE LOCAL MARKET AREA FOR WORK PERFORMED TO
- 4 RECALIBRATE AN ADVANCED DRIVER ASSISTANCE SYSTEM.
- 5 (E) (1) SUBJECT TO PARAGRAPH (2) OF THIS SUBSECTION, AN
- 6 AUTOMOTIVE REPAIR FACILITY IS NOT LIMITED TO AUTOMOTIVE GLASS, TOOLING,
- 7 EQUIPMENT, OR REPAIR PROCEDURES PROVIDED BY THE VEHICLE
- 8 MANUFACTURER.
- 9 (2) RECALIBRATION OF AN ADVANCED DRIVER ASSISTANCE SYSTEM
- 10 PERFORMED BY AN AUTOMOTIVE REPAIR FACILITY SHALL MEET OR EXCEED THE
- 11 MOTOR VEHICLE MANUFACTURER'S SPECIFICATIONS.
- 12 (3) AN AUTOMOTIVE REPAIR FACILITY MAY NOT CHARGE FOR
- 13 SERVICES THAT ARE NOT PERFORMED IN ACCORDANCE WITH THE MOTOR VEHICLE
- 14 MANUFACTURER'S SPECIFICATIONS.
- 15 (F) IF RECALIBRATION OF AN ADVANCED DRIVER ASSISTANCE SYSTEM IS
- 16 REQUIRED AND IS NOT PERFORMED OR SUCCESSFULLY COMPLETED, THE
- 17 AUTOMOTIVE REPAIR FACILITY SHALL INFORM THE CUSTOMER ELECTRONICALLY
- 18 OR IN WRITING THAT THE RECALIBRATION WAS NOT PERFORMED OR WAS
- 19 UNSUCCESSFUL AND ADVISE THE CUSTOMER THAT THE MOTOR VEHICLE SHOULD
- 20 BE TAKEN TO:
- 21 (1) A MOTOR VEHICLE MANUFACTURER'S CERTIFIED DEALERSHIP;
- 22 **OR**
- 23 (2) A QUALIFIED AUTOMOTIVE REPAIR FACILITY CAPABLE OF
- 24 PERFORMING THE RECALIBRATION OF AN ADVANCED DRIVER ASSISTANCE SYSTEM
- 25 THAT MEETS OR EXCEEDS THE MOTOR VEHICLE MANUFACTURER'S
- 26 SPECIFICATIONS.

- A violation of any provision of this subtitle is an unfair [or], deceptive, OR ABUSIVE
- 29 TRADE practice within the meaning of Title 13 of this article and is subject to the
- 30 enforcement and penalty provisions contained in Title 13 of this article.
