A BILL ENTITLED

1 AN ACT concerning

2 **Service, Stipends, and Scholarships – Maryland Corps Program – Established**

3 FOR the purpose of establishing the Maryland Corps Program; providing for the purpose
4 of the Program; requiring a certain Board of Directors to administer and manage the
5 Program; providing for the composition of the Board; providing for the appointment,
6 terms, and removal of members of the Board; providing that members of the Board
7 may not receive certain compensation but are entitled to certain reimbursement;
8 requiring the Governor's Office on Service and Volunteerism within the Governor's
9 Office of Community Initiatives to provide certain staffing and assistance to the
10 Board and a certain operator; requiring the Board to submit a certain Request for
11 Proposals (RFP) on or before a certain date; requiring the RFP to include certain
12 elements and expectations for a certain operator; requiring certain corps participants
13 to serve a certain nonprofit or governmental entity for a certain period of time;
14 authorizing certain corps participants to receive certain stipends and certain
15 scholarships under certain circumstances; specifying the use of certain scholarships;
16 establishing the Maryland Corps Program Fund; specifying the purpose of the Fund;
17 requiring the Board to administer the Fund; specifying that the Fund is a continuing,
18 nonlapsing fund that is not subject to a certain provision of law; requiring the State
19 Treasurer to hold the Fund separately and invest the money in the Fund in a certain
20 manner; requiring the Comptroller to account for the Fund; providing for the
21 composition and uses of the Fund; prohibiting any unspent portion of the Fund from
22 being transferred or used in a certain manner; requiring the Board to prepare certain
23 reports annually; authorizing the Fund to be subject to a certain audit; requiring the
24 Governor to include certain appropriations in the State budget in certain fiscal years
25 for certain purposes; requiring the Board to explore certain possibilities; requiring
26 the Board to submit certain reports to the Governor and the General Assembly in
27 accordance with certain provisions of law; providing for the staggering of the terms

32 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
 33 That the Laws of Maryland read as follows:

15 EDUCATION.

16 (D) "FUND" MEANS THE MARYLAND CORPS PROGRAM FUND.

17 (E) "PROGRAM" MEANS THE MARYLAND CORPS PROGRAM.

20 ADMINISTERED AND MANAGED BY THE BOARD.

21 (B) THE PURPOSE OF THE PROGRAM IS TO:

22 (1) PROVIDE MEANINGFUL SERVICE OPPORTUNITIES TO AT LEAST
23 100 CORPS PARTICIPANTS THAT WILL ADDRESS THE SOCIAL NEEDS OF THE
24 COMMUNITY;

25 (2) EQUIP CORPS PARTICIPANTS WITH THE SKILLS THAT WILL
26 ENABLE THEM TO SUCCESSFULLY MAKE THE TRANSITION FROM HIGH SCHOOL TO
27 AN INSTITUTION OF HIGHER EDUCATION; AND

1 **(3) PROVIDE SCHOLARSHIPS TO CORPS PARTICIPANTS WHO HAVE**
2 **COMPLETED THE PROGRAM TO BE USED AT INSTITUTIONS OF HIGHER EDUCATION**
3 **TOWARD VOCATIONAL CERTIFICATES, ASSOCIATE'S DEGREES, OR BACHELOR'S**

24 **(E) (1) THE TERM OF A MEMBER OF THE BOARD IS 4 YEARS.**

26 **THE TERMS PROVIDED FOR MEMBERS ON JUNE 1, 2016.**

27 **(3) AT THE END OF A TERM, A MEMBER CONTINUES TO SERVE UNTIL**
28 **A SUCCESSOR IS APPOINTED AND QUALIFIES.**

6 **(3) A MEMBER APPOINTED BY THE GOVERNOR MAY BE REMOVED BY**
7 **THE GOVERNOR FOR THE REASONS STATED IN PARAGRAPH (4) OF THIS**

8 **(4) CREATING A SELECTIVE RECRUITMENT PROCESS FOR CORPS**
9 **PARTICIPANTS, GIVING PRIORITY TO LOW-INCOME INDIVIDUALS;**

10 **(5) CREATING AND IMPLEMENTING AN ORIENTATION AND TRAINING**
11 **PROGRAM FOR CORPS PARTICIPANTS AND THE NONPROFIT OR GOVERNMENT**
12 **AGENCIES WHERE CORPS PARTICIPANTS EFFECTUATE THEIR SERVICE;**

13 **(6) PROVIDING SUPPORT TO CORPS PARTICIPANTS IN FINDING**
14 **PLACEMENTS;**

15 **(7) EMPHASIZING AND ENCOURAGING THE IMPORTANCE OF BEING A**
16 **SUCCESSFUL CONTRIBUTOR TO SOCIETY, A MEASURE OF WHICH IS A VOCATIONAL**
17 **CERTIFICATE, AN ASSOCIATE'S DEGREE, OR A BACHELOR'S DEGREE;**

18 **(8) CREATING TOOLS TO MEASURE THE SUCCESS OF CORPS**
19 **PARTICIPANTS AS THEY TRANSITION FROM HIGH SCHOOL TO AN INSTITUTION OF**
20 **HIGHER EDUCATION FOR A VOCATIONAL CERTIFICATE, AN ASSOCIATE'S DEGREE, OR**
21 **A BACHELOR'S DEGREE;**

22 **(9) FACILITATING THE AWARD OF STIPENDS FOR CORPS**
23 **PARTICIPANTS DURING THEIR YEAR OF SERVICE;**

24 **(10) FACILITATING THE AWARD OF SCHOLARSHIPS FOR CORPS**
25 **PARTICIPANTS WHO COMPLETE THE PROGRAM TO BE USED AT INSTITUTIONS OF**
26 **HIGHER EDUCATION TOWARD VOCATIONAL CERTIFICATES, ASSOCIATE'S DEGREES,**
27 **OR BACHELOR'S DEGREES; AND**

7 **(E) (1) THE STATE TREASURER SHALL HOLD THE FUND SEPARATELY**
8 **AND SHALL INVEST THE MONEY IN THE FUND IN THE SAME MANNER AS OTHER**
9 **STATE MONEY MAY BE INVESTED.**

10 **(2) ANY INVESTMENT EARNINGS OF THE FUND SHALL BE CREDITED**
11 **TO THE FUND.**

12 **(F) THE COMPTROLLER SHALL ACCOUNT FOR THE FUND.**

13 **(G) THE BOARD:**

14 **(1) MAY ACCEPT ANY GIFT OR GRANT FROM ANY PERSON FOR THE**
15 **FUND;**

16 **(2) SHALL USE ANY GIFT OR GRANT THAT IT RECEIVES FOR THE**
17 **REASONS STATED UNDER SUBSECTION (B) OF THIS SECTION; AND**

18 **(3) SHALL DEPOSIT ANY GIFT OR GRANT THAT IT RECEIVES FOR THE**
19 **FUND WITH THE STATE TREASURER.**

20 **(H) THE FUND CONSISTS OF:**

21 **(1) MONEY APPROPRIATED UNDER § 24-1109 OF THIS SUBTITLE;**

22 **(2) GIFTS OR GRANTS RECEIVED BY THE BOARD FOR THE FUND;**

23 **(3) INVESTMENT EARNINGS OF THE FUND; AND**

24 **(4) ANY OTHER MONEY FROM ANY OTHER SOURCE ACCEPTED FOR**
25 **THE BENEFIT OF THE FUND.**

26 **(I) THE FUND MAY BE USED ONLY FOR:**

27 **(1) PROVIDING STIPENDS TO CORPS PARTICIPANTS;**

1 **(2) PROVIDING SCHOLARSHIPS TO CORPS PARTICIPANTS WHO HAVE**
2 **COMPLETED THE PROGRAM TO BE USED AT INSTITUTIONS OF HIGHER EDUCATION**
3 **IN THE STATE TOWARD VOCATIONAL CERTIFICATES, ASSOCIATE’S DEGREES, AND**
4 **BACHELOR’S DEGREES;**

5 **(3) COVERING EXPENSES INCURRED BY THE BOARD, INCLUDING**
6 **EXPENSES INCURRED DURING THE DEVELOPMENT, ISSUANCE, AWARDING, AND**
7 **FUNDING OF THE RFP; AND**

8 **(4) COVERING EXPENSES INCURRED BY THE OPERATOR SELECTED**
9 **UNDER § 24-1105 OF THIS SUBTITLE, AS DETERMINED BY THE BOARD TO BE**
10 **RELEVANT TO THE SUCCESSFUL OPERATION OF THE PROGRAM.**

11 **(J) ANY UNSPENT PORTION OF THE FUND MAY NOT BE TRANSFERRED OR**
12 **REVERT TO THE GENERAL FUND OF THE STATE BUT SHALL REMAIN IN THE FUND**
13 **TO BE USED FOR THE PURPOSES SPECIFIED IN THIS SUBTITLE.**

14 **(K) (1) BEGINNING WITH FISCAL YEAR 2018, AT THE END OF THE FISCAL**
15 **YEAR, THE BOARD SHALL PREPARE AN ANNUAL REPORT OF THE FUND THAT**
16 **INCLUDES AN ACCOUNTING OF ALL FINANCIAL RECEIPTS AND EXPENDITURES TO**
17 **AND FROM THE FUND.**

18 **(2) THE BOARD SHALL SUBMIT A COPY OF THE REPORT TO THE**

1 **(C) FOR FISCAL YEAR 2020 AND EACH FISCAL YEAR THEREAFTER, THE**
2 **GOVERNOR SHALL INCLUDE AN APPROPRIATION OF AT LEAST \$2,000,000 IN THE**
3 **STATE BUDGET FOR THE FUND FOR THE BOARD TO:**

4 **(1) PROVIDE STIPENDS TO CORPS PARTICIPANTS;**

5 **(2) PROVIDE SCHOLARSHIPS TO CORPS PARTICIPANTS WHO HAVE**
6 **COMPLETED THE PROGRAM TO BE USED AT INSTITUTIONS OF HIGHER EDUCATION**
7 **IN THE STATE TOWARD VOCATIONAL CERTIFICATES, ASSOCIATE'S DEGREES, AND**
8 **BACHELOR'S DEGREES;**

9 **(3) COVER EXPENSES INCURRED BY THE BOARD, INCLUDING**
10 **EXPENSES INCURRED DURING THE DEVELOPMENT, ISSUANCE, AWARDING, AND**
11 **FUNDING OF THE RFP; AND**

12 **(4) COVER EXPENSES INCURRED BY THE OPERATOR SELECTED**
13 **UNDER § 24-1105 OF THIS SUBTITLE, AS DETERMINED BY THE BOARD TO BE**

17 **(1) ACCESSING FEDERAL OR OTHER GRANT FUNDING FOR THE**
18 **PROGRAM; AND**

19 **(2) AWARDING CORPS PARTICIPANTS WITH ACADEMIC CREDIT FOR**
20 **THEIR SERVICE.**

5 be appointed by the President of the Senate, the Speaker of the House, and the Governor
6 on or before September 1, 2016.

7 SECTION 5. AND BE IT FURTHER ENACTED, That this Act shall take effect June
8 1, 2016.
