A BILL ENTITLED

1 AN ACT concerning

2 **Charles County Board of Education – Vacancy Procedures – Timing and Video**
3 **Streaming and Archiving**

4 FOR the purpose of requiring the Charles County Board of Education to fill a vacancy on
5 the county board within a certain number of days after the vacancy occurs; requiring
6 the county board to make certain materials publicly available on its website; and
7 generally relating to filling a vacancy on the Charles County Board of Education.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
19 That the Laws of Maryland read as follows:

20 **Article – Education**

21 3–501.

22 (a) (1) The Charles County Board consists of:

23 (i) Nine elected members; and

1 (ii) One student member.

2 (f) (1) **[The] WITHIN 60 DAYS AFTER A VACANCY OCCURS ON THE**
3 **COUNTY BOARD, THE** elected members of the county board shall select a qualified
4 individual to fill **[any] THE** vacancy on the board for the remainder of that term and until
5 a successor is elected and qualifies.

6 (2) An individual appointed to fill a vacancy of an elected member shall be
7 a resident of the same county commissioner district as that of the vacating member.

8 (3) **(I)** An interview of an applicant for a vacancy on the board shall be
9 conducted by the board at a meeting open to the public.

10 **(II) THE BOARD SHALL MAKE PUBLICLY AVAILABLE ON ITS**
11 **WEBSITE:**

12 **1. LIVE VIDEO STREAMING OF EACH PUBLIC MEETING**
13 **UNDER THIS PARAGRAPH; AND**

14 **2. A COMPLETE AND UNEDITED ARCHIVED VIDEO**
15 **RECORDING OF EACH PUBLIC MEETING THAT IS LIVESTREAMED IN ACCORDANCE**
16 **WITH THIS PARAGRAPH.**

17 (4) (i) The board shall publish a list of the names of the applicants for
18 a vacancy on the board at least 2 weeks before the interview of the first applicant is
19 scheduled to occur.

20 (ii) Public notice of the date, time, and location of each interview
21 shall be published:

22 1. At least 2 weeks before the interview is scheduled to occur;
23 and

24 2. In the same manner as a public notice of a regular meeting
25 of the board is published.

26 (5) The board is not required to conduct discussions of the applicants or
27 make the final selection of the member to fill a vacancy of the elected member at a meeting
28 open to the public.

29 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
30 1, 2024.
