- 4 FOR the purpose of altering the application of certain high performance building 5 requirements to apply to capital projects for which a certain amount of funding for 6 certain aspects of the project is from State funds; repealing a requirement that the 7 Maryland Green Building Council develop guidelines for new public school buildings 8 to achieve a certain rating without requiring an independent certification that the 9 buildings have achieved the required standards; requiring the Maryland Green Building Council to ensure that certain State buildings, public schools, and 10 11 community colleges meet certain high performance building requirements; 12 prohibiting the use of certain guidelines for a new public school building to meet 13 certain high performance building requirements; and generally relating to high performance building requirements and green building guidelines. 14

- 2 (a) There is a Maryland Green Building Council.
- 3 (f) The Maryland Green Building Council shall:
- 4 (1) evaluate current high performance building technologies;
- 5 (2) provide recommendations concerning the most cost-effective green 6 building technologies that the State might consider requiring in the construction of State 7 facilities, including consideration of the additional cost associated with the various 8 technologies;
- 9 (3) provide recommendations concerning how to expand green building in 10 the State;
- 11 (4) develop a list of building types for which green building technologies 12 should not be applied, taking into consideration the operational aspects of facilities 13 evaluated, and the utility of a waiver process where appropriate;
- 14 (5) establish a process for receiving public input; and
- 15 (6)develop guidelines for new public school buildings to achieve the 16 equivalent of the current version of the U.S. Green Building Council's LEED (Leadership 17 in Energy and Environmental Design) Green Building Rating System Silver rating or a comparable rating system or building code as authorized in § 3–602.1 of this article without 18 requiring an independent certification that the buildings have achieved the required 19 20standards Ensure that State buildings, public schools, and community 21COLLEGES THAT ARE REQUIRED TO MEET THE HIGH PERFORMANCE BUILDING 22REQUIREMENTS UNDER § 3-602.1 OF THIS ARTICLE OR § 5-312 OF THE EDUCATION 23ARTICLE MEET THOSE REQUIREMENTS.
 - SECTION 2. AND BE IT FURTHER ENACTED, That any guidelines developed before July 1, 2020, by the Maryland Green Building Council to implement § 4–809(f)(6) of the State Finance and Procurement Article may not be used for a new public school building to meet the high performance building requirements under § 5–312 of the Education Article or § 3–602.1 of the State Finance and Procurement Article.
- SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2020.
