BY repealing and reenacting, with amendments, Chapter 470 of the Acts of the General Assembly of 2018 Section 5 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: Chapter 470 of the Acts of 2018 SECTION 5. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2019. It shall remain effective for a period of [3] 8 years and 3 months 11 YEARS and, at the end of September 30, [2022] 2027 JUNE 30, 2030, this Act, with no further action required by the General Assembly, shall be abrogated and of no further force and effect. AND BE IT FURTHER ENACTED, That, in the annual report the State Board of Physicians is required to submit under § 14–205.1 of the Health Occupations Article, on or before October 1, 2023, the Board shall include an update on the status of the
