A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2006 – Baltimore City –**
3 **Baltimore Clayworks**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2006
5 to extend the date by which the Board of Trustees of Baltimore Clayworks, Inc.
6 must present evidence that a matching fund will be provided.

7 BY repealing and reenacting, with amendments,
8 Chapter 46 of the Acts of the General Assembly of 2006, as amended by Chapter
9 219 of the Acts of the General Assembly of 2008
10 Section 1(3) Item ZA01(R) and ZA02(W)

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
12 MARYLAND, That the Laws of Maryland read as follows:

22 rooms, and the repair, renovation, and reconstruction of
23 upgrades to the plumbing, electrical, and roofing systems of
24 Baltimore Clayworks, Inc., located in Baltimore City, subject
25 to a requirement that the grantee grant and convey a historic
