(Transit Benefit for State Employees)

- 5 FOR the purpose of requiring the Maryland Transit Administration to provide certain 6 ridership services to certain State permanent employees of the Executive Branch of 7 State government on certain transit vehicles; prohibiting the Administration from 8 seeking certain fees or reimbursement; authorizing the Administration to adopt 9 certain regulations; requiring the Maryland Department of Transportation and the 10 Department of Budget and Management to report to certain committees of the General Assembly on or before a certain date; defining a certain term; and generally 11 12 relating to the Maryland Transit Administration and ridership for State employees.
