## A BILL ENTITLED

1 AN ACT concerning

2 **Anne Arundel County – Superintendent of Schools – Compensation for**  
3 **Unused Leave on Termination of Employment**

4 FOR the purpose of providing that the Anne Arundel County Board of Education, on  
5 termination of the employment of the county superintendent of schools, may  
6 compensate the county superintendent for unused leave earned while employed  
7 as county superintendent only in a certain manner; and generally relating to  
8 compensation for the Anne Arundel County superintendent of schools on  
9 termination of employment.

10 BY repealing and reenacting, with amendments,  
11 Article – Education  
12 Section 4–202  
13 Annotated Code of Maryland  
14 (2008 Replacement Volume and 2013 Supplement)

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
16 MARYLAND, That the Laws of Maryland read as follows:

17 **Article – Education**

18 4–202.

19 (a) (1) Except as provided in paragraph (2) of this subsection, each county  
20 superintendent is entitled to the compensation set by the county board.

21 (2) In Prince George’s County, the Chief Executive Officer is entitled  
22 to the compensation set by the contract with the county board.

23 (b) (1) The salary of a county superintendent may not be decreased during  
24 his term of office.

1                   (2)    Each county superintendent shall devote full time to public school  
2 business.

3            (C)    (1)    **IN THIS SUBSECTION, "LEAVE" MEANS:**

4                            (I)    **ANNUAL LEAVE;**

5                            (II)   **COMPENSATORY LEAVE;**

6                            (III)   **SICK LEAVE; AND**

7                            (IV)   **PERSONAL LEAVE.**

8                            (2)    **IN ANNE ARUNDEL COUNTY, ON TERMINATION OF**  
9 **EMPLOYMENT, WHETHER VOLUNTARY OR INVOLUNTARY, THE COUNTY BOARD**  
10 **MAY COMPENSATE THE COUNTY SUPERINTENDENT FOR UNUSED LEAVE THAT**  
11 **THE COUNTY SUPERINTENDENT EARNED WHILE EMPLOYED BY THE COUNTY**  
12 **BOARD ONLY AT A RATE THAT IS COMPUTED AND PAID IN THE SAME MANNER AS**  
13 **THAT COMPUTED AND PAID TO A CERTIFICATED EMPLOYEE OF THE COUNTY**  
14 **BOARD ON TERMINATION OF EMPLOYMENT.**

15                   SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
16 October 1, 2014.
