BY repealing and reenacting, with amendments, Article – Family Law Section 4–506(j) and 4–507(a)(3) Annotated Code of Maryland (2012 Replacement Volume and 2014 Supplement) SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: Article - Family Law 4-506.Except as provided in paragraphs (2) and (3) of this subsection, all relief (1) granted in a final protective order shall be effective for the period stated in the order, not to exceed 1 year.
