3 FOR the purpose of prohibiting financial aid that is awarded to a student by a public 4 institution of higher education from being reduced by any other form of financial aid $\mathbf{5}$ awarded to the student beginning in a certain academic year; prohibiting a public 6 institution of higher education from considering certain scholarships when 7 assembling certain financial aid packages; authorizing financial aid awarded by a 8 public institution of higher education to be reduced in a certain order under certain 9 circumstances; defining certain terms; and generally relating to financial aid at 10 public institutions of higher education.
