A BILL ENTITLED

1 AN ACT concerning

2 **Frederick County Board of Education – Membership and Employment**

3 FOR the purpose of repealing a certain provision of law prohibiting certain individuals
4 in Frederick County from being elected to or serving on the county board of
5 education; repealing a certain provision of law prohibiting certain individuals in
6 Frederick County from being hired as an administrator or a teacher under
7 certain circumstances; and generally relating to certain individuals who may
8 serve on and may be hired by the Frederick County Board of Education.

25 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
26 MARYLAND, That the Laws of Maryland read as follows:

Article – Education

2 3–5B–01.

3 (a) The Frederick County Board consists of eight members as follows:

4 (1) Seven members elected from the county at large; and

5 (2) One nonvoting student member.

6 (b) (1) A candidate elected to the county board shall be a resident and
7 registered voter of Frederick County.8 (2) Any member who no longer resides in the county may not continue
9 as a member of the board.

11 (a) An individual who is married to an administrator or teacher of the county
12 board may not be elected to or serve on the county board.13 (b) An individual who is married to a member of the county board may not be
14 hired as an administrator or teacher by the county board unless the individual's
15 spouse first resigns from the county board.]16 SECTION 2. AND BE IT FURTHER ENACTED, That Section(s) 3–5B–03,
17 3–5B–04, and 3–5B–05, respectively, of Article – Education of the Annotated Code of
18 Maryland be renumbered to be Section(s) 3–5B–02, 3–5B–03, and 3–5B–04,
19 respectively.20 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
21 July 1, 2012.
