#### 1 AN ACT concerning

# Cybersecurity Scholarship Program – Alterations and Maryland Cybersecurity Loan Assistance Repayment Program – Establishment

- 4 FOR the purpose of altering certain criteria for the Cybersecurity Public Service  $\mathbf{5}$ Scholarship Program, including increasing the number of years a recipient may hold 6 an award, expanding the qualifying positions for a scholarship recipient to fulfill a 7 work obligation, and establishing criteria for part-time students to be eligible for the 8 scholarship, hold an award, and fulfill a work obligation; requiring the State 9 Department of Education to provide information on the Program to high school 10 students who participate in career and technology programs related to cybersecurity; 11 establishing the Maryland Cybersecurity Loan Assistance Repayment Program; and 12generally relating to the Cybersecurity Public Service Scholarship Program and the 13 Maryland Cybersecurity Loan Assistance Repayment Program.
