BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: 12 Article - Natural Resources 13 14 10-410. 15 (a) Except as provided in paragraphs (2) and (3) of this subsection, a person may not hunt any game bird or mammal on Sundays. 16 17 (2)The following persons may hunt the specified game birds and 18 mammals on Sundays: 19 A person using State certified raptors to hunt game birds or (i) 20 mammals during open season; 21(ii) An unarmed person participating in an organized fox chase 22 to chase foxes:
