A BILL ENTITLED

1 AN ACT concerning

2 **Baltimore County – Class B–ECF/DS (Education Conference Facility/Dining**
3 **Service) License – Towson University**

4 FOR the purpose of authorizing the Board of License Commissioners for Baltimore County
5 to issue a Class B–ECF/DS (Education Conference Facility/Dining Service) license
6 for use at certain Towson University events; and generally relating to alcoholic
7 beverages licenses in Baltimore County.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
19 That the Laws of Maryland read as follows:

20 **Article – Alcoholic Beverages**

21 13–102.

22 This title applies only in Baltimore County.

23 13–1001.

1 (a) There is a Class B–ECF/DS (Education Conference Facility/Dining Service)
2 beer, wine, and liquor license.

3 (b) The Board may issue the license to an individual who is:

4 (1) authorized by the University of Maryland, Baltimore County **OR**
5 **TOWSON UNIVERSITY** to:

6 (i) act on behalf of the campus under the license; and

7 (ii) be subject to the penalties, conditions, and restrictions under this
8 title; and

9 (2) a resident of the State.

10 (c) (1) The license authorizes the license holder to sell beer, wine, and liquor
11 for on–premises consumption from multiple designated outlets on the [University’s]
12 campus **OF THE UNIVERSITY ON BEHALF OF WHICH THE LICENSE HOLDER IS**
13 **AUTHORIZED TO ACT** only at [University–related] **UNIVERSITY–RELATED** events
14 catered by the [University’s] **UNIVERSITY’S** campus dining services contractor.

15 (2) Beer, wine, and liquor purchased at a designated outlet are to be
16 consumed in the confines of that outlet and may not be transported to another outlet.

17 (d) All profits from the retail sale of beer, wine, and liquor shall be deposited in
18 the auxiliary services account of the University of Maryland, Baltimore County **OR**
19 **TOWSON UNIVERSITY, AS APPROPRIATE.**

20 (e) The Board:

21 (1) may regulate the manner in which beer, wine, and liquor are dispensed
22 under the license;

23 (2) before issuing the license, shall designate the exact campus locations
24 for the outlets for the sale of beer, wine, and liquor;

25 (3) shall maintain a map and description of the designated outlets for
26 verification on the renewal of the license; and

27 (4) shall require the University of Maryland, Baltimore County **OR**
28 **TOWSON UNIVERSITY, AS APPROPRIATE,** to report to the Board at least 5 days before a
29 [University–related] **UNIVERSITY–RELATED** event at which beer, wine, or liquor is
30 intended to be sold or served.

31 (f) The license holder may sell beer, wine, and liquor during the hours and days
32 as set out for a Class B beer, wine, and liquor license under § 13–2004 of this title.

1 (g) The annual license fee is \$2,000.

2 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
3 1, 2023.
