4 FOR the purpose of ~~regulating how public senior higher education institutions may adjust~~

7 aid awarded by a public senior higher education institution to be reduced only under
8 certain circumstances; ~~and up to a certain amount;~~ prohibiting financial aid awarded
9 ~~by a public senior higher education institution from being reduced under certain~~
10 ~~circumstances; requiring certain financial aid to be reduced in a specific order;~~

10 (B) A PUBLIC SENIOR HIGHER EDUCATION INSTITUTION MAY REDUCE
11 INSTITUTIONAL GIFT AID OFFERS AS A RESULT OF PRIVATE SCHOLARSHIP AWARDS
12 ONLY UNDER THE CIRCUMSTANCES DESCRIBED IN SUBSECTIONS (C) THROUGH (E)
13 OF THIS SECTION.

14 (C) IF A STUDENT'S TOTAL GIFT AID FROM ALL SOURCES EXCEEDS THE
15 STUDENT'S FINANCIAL NEED, A PUBLIC SENIOR HIGHER EDUCATION INSTITUTION
16 MAY REDUCE THE STUDENT'S INSTITUTIONAL GIFT AID UNTIL THE STUDENT'S
17 TOTAL GIFT AID NO LONGER EXCEEDS THE STUDENT'S FINANCIAL NEED; UNTIL THE
18 STUDENT'S TOTAL GIFT AID NO LONGER EXCEEDS THE STUDENT'S FINANCIAL NEED.

25 (D) IN ADDITION TO THE REDUCTION AUTHORIZED IN SUBSECTION (C) OF
26 THIS SECTION, A PUBLIC SENIOR HIGHER EDUCATION INSTITUTION MAY FURTHER
27 REDUCE A STUDENT'S INSTITUTIONAL GIFT AID IF THE INSTITUTION RECEIVES
28 APPROVAL FROM THE ORGANIZATION THAT AWARDED THE PRIVATE SCHOLARSHIP
29 FUNDS THAT TRIGGERED THE REDUCTION AUTHORIZED IN SUBSECTION (C) OF THIS
30 SECTION.

31 (E) A PUBLIC SENIOR HIGHER EDUCATION INSTITUTION MAY REDUCE A
32 STUDENT ATHLETE'S INSTITUTIONAL GIFT AID IN ORDER TO COMPLY WITH THE

1 NATIONAL COLLEGIATE ATHLETIC ASSOCIATION'S INDIVIDUAL OR TEAM
2 FINANCIAL AID RESTRICTIONS.

3 SECTION 2. AND BE IT FURTHER ENACTED, That nothing in this Act may be
4 construed to violate the provisions of federal law or regulations relating to the award of any
5 need-based financial aid or any federal aid.

6 SECTION 3. AND BE IT FURTHER ENACTED, That, if any provision of this Act or
7 the application thereof to any person or circumstance is held invalid for any reason in a
8 court of competent jurisdiction, the invalidity does not affect other provisions or any other
9 application of this Act that can be given effect without the invalid provision or application,
10 and for this purpose the provisions of this Act are declared severable.

11 SECTION 4. AND BE IT FURTHER ENACTED, That this Act shall take effect July
12 1, 2017.
