

E. 0.02, WHEN THE PARENT KEEPS THE CHILD OR CHILDREN OVERNIGHT FOR MORE THAN 29% (AT LEAST 106 OVERNIGHTS), BUT LESS THAN 30% (NOT MORE THAN 109 OVERNIGHTS), OF THE YEAR.

(3) Subject to the provisions of paragraphs (4) and (5) of this subsection,
the parent owing the greater amount under paragraph (2) of this subsection shall owe the

(4) In addition to the amount of the child support owed under paragraph (3) of this subsection, if either parent incurs child care expenses under subsection (g) of this section, health insurance expenses under subsection (h)(1) of this section, extraordinary medical expenses under subsection (h)(2) of this section, or additional expenses under subsection (i) of this section, the expense shall be divided between the parents in proportion to their respective adjusted actual incomes.
