10 11	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:
12	Article - Election Law
13	16–201.
14	(a) A person may not willfully and knowingly:
15 16	(1) (i) impersonate another person in order to vote or attempt to vote; or
17	(ii) vote or attempt to vote under a false name;
18 19	(2) vote more than once for a candidate for the same office or for the same ballot question;
20 21	(3) vote or attempt to vote more than once in the same election, or vote in more than one election district or precinct;



- 1 (4) vote in an election district or precinct without the legal authority 2 to vote in that election district or precinct;
- 3 (5) influence or attempt to influence a voter's voting decision through the use of force, threat, menace, intimidation, bribery, reward, or offer of reward;
- 5 (6) influence or attempt to influence a voter's decision whether to go to 6 the polls to cast a vote through the use of force, fraud, threat, menace, intimidation, 7 bribery, reward, or offer of reward; or
- 8 (7) engage in conduct that results or has the intent to result in the 9 denial or abridgement of the right of any citizen of the United States to vote on account of race, color, or disability.
- 11 (b) Except as provided in § 16–1002 of this title, a person who violates this section is guilty of [a misdemeanor and on conviction is subject to a fine of not more than \$2,500 or imprisonment for not more than 5 years or both] A FELONY AND ON CONVICTION IS SUBJECT TO A FINE OF NOT MORE THAN \$100,000 AND IMPRISONMENT FOR NOT MORE THAN 5 YEARS.
- 16 (c) A person who violates this section is subject to § 5–106(b) of the Courts 17 Article.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2013.
