18 19	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

22	(a) In this section, "economic development program" means:

20 21 22 23	(c) On or before December 31, 2013, and each year thereafter, the Departmen shall submit a report on the economic development programs that were administered by the Department during the previous fiscal year to the Governor and, in accordance with 2–1257 of the State Government Article, the General Assembly.

23	(a) In this subtitle the following words have the meanings indicated.
24 25	(f) "Minority business enterprise" means any legal entity, except a joint venture, that is:
26	(1) organized to engage in commercial transactions;
27 28	(2) at least 51% owned and controlled by 1 or more individuals who are socially and economically disadvantaged; and

managed by, and the daily business operations of which are controlled

by, one or more of the socially and economically disadvantaged individuals who own it.
