A BILL ENTITLED

1 AN ACT concerning

2 **Criminal Procedure – Charging Procedures and Documents – Citation**

3 FOR the purpose of modifying the categories of offenses for which a police officer is required
4 to charge by citation; repealing a provision of law authorizing a police officer to
5 charge by citation for certain offenses; modifying the circumstances under which a
6 police officer may charge a defendant by citation; and generally relating to charging
7 procedures and documents.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

19 That the Laws of Maryland read as follows:

20 **Article – Criminal Procedure**

21 4–101.

22 (a) (1) In this section the following words have the meanings indicated.

23 (2) (i) “Citation” means a written charging document that a police
24 officer or fire marshal issues to a defendant, alleging the defendant has committed a crime.

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.



1 (ii) "Citation" does not include an indictment, information, or
2 statement of charges.

3 (3) "Fire marshal" means:

4 (i) the State Fire Marshal;

5 (ii) a deputy State fire marshal; or

6 (iii) as designated under § 6–304 of the Public Safety Article:

7 1. an assistant State fire marshal; or

8 2. a special assistant State fire marshal.

9 (4) "Police officer" has the meaning stated in § 2–101 of this article.

10 (c) (1) [(i)] Subject to paragraph (2) of this subsection, in addition to any
11 other law allowing a crime to be charged by citation, a police officer shall charge by citation
12 for:

13 [1.] (I) any misdemeanor or local ordinance violation that
14 does not carry a penalty of imprisonment;

15 [2.] (II) any **OTHER** misdemeanor **NOT INVOLVING**
16 **SERIOUS INJURY OR AN IMMEDIATE HEALTH RISK** or local ordinance violation for which
17 the maximum penalty of imprisonment is [90 days] **18 MONTHS** or less, except:

18 [A.] 1. failure to comply with a peace order under § 3–1508
19 of the Courts Article;

20 [B.] 2. failure to comply with a protective order under §
21 4–509 of the Family Law Article;

22 [C.] 3. violation of a condition of pretrial or posttrial
23 release while charged with a sexual crime against a minor under § 5–213.1 of this article;

24 [D.] 4. possession of an electronic control device after
25 conviction of a drug felony or crime of violence under § 4–109(b) of the Criminal Law Article;

26 [E.] 5. violation of an out-of-state domestic violence order
27 under § 4–508.1 of the Family Law Article; or

28 [F.] 6. abuse or neglect of an animal under § 10–604 of the
29 Criminal Law Article; or

1 [3.] (III) possession of marijuana under § 5-601 of the
2 Criminal Law Article.

3 [(ii) Subject to paragraph (2) of this subsection, in addition to any
4 other law allowing a crime to be charged by citation, a police officer may charge by citation
5 for:

6 1. sale of an alcoholic beverage to an underage drinker or
7 intoxicated person under § 6-304, § 6-307, § 6-308, or § 6-309 of the Alcoholic Beverages
8 Article;

9 2. malicious destruction of property under § 6-301 of the
10 Criminal Law Article, if the amount of damage to the property is less than \$500; or

11 3. misdemeanor theft under § 7-104(g)(2) of the Criminal
12 Law Article.]

13 (2) A police officer may charge a defendant by citation [only] if:

14 (i) the officer is satisfied with the defendant's evidence of identity;

15 (ii) the officer reasonably believes that the defendant will comply
16 with the citation;

17 (iii) the officer reasonably believes that the failure to charge on a
18 statement of charges will not pose a threat to public safety;

19 (iv) the defendant is not subject to arrest for another [criminal
20 charge] **ALLEGED MISDEMEANOR INVOLVING SERIOUS INJURY OR IMMEDIATE**
21 **HEALTH RISK, AN ALLEGED FELONY** arising out of the same incident, **OR AN OPEN**
22 **WARRANT**; and

23 (v) the defendant complies with all lawful orders by the officer.

24 (3) A police officer who has grounds to make a warrantless arrest for an
25 offense that may be charged by citation under this subsection may:

26 (i) issue a citation in lieu of making the arrest; or

27 (ii) make the arrest and subsequently issue a citation in lieu of
28 continued custody.

29 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
30 October 1, 2017.
