1 AN ACT concerning

2 **Washington County – Office of the County Attorney**

3 FOR the purpose of authorizing the County Commissioners of Washington County to
4 employ one or more County Attorneys; requiring the salaries for a County
5 Attorney to be set in the annual county budget; authorizing the County
6 Commissioners to employ attorneys; authorizing the Office of the County
7 Attorney to perform certain duties; authorizing the Office of the County
8 Attorney, under certain circumstances, to hire temporarily special counsel to
9 perform certain duties; repealing language made obsolete by this Act; and
10 generally relating to legal services for the County Commissioners of Washington
11 County.

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
2 MARYLAND, That the Laws of Maryland read as follows:

3 **Article 22 – Washington County**

4 **1–113.**

5 **(A) (1) THE COUNTY COMMISSIONERS MAY EMPLOY ONE OR MORE**
6 **COUNTY ATTORNEYS TO ASSIST IN THE TRANSACTION OF PUBLIC BUSINESS.**

7 **(2) THE SALARY FOR A COUNTY ATTORNEY SHALL BE PROVIDED**
8 **FOR IN THE BUDGET.**

9 **(B) A COUNTY ATTORNEY MAY BE EMPLOYED BY THE COUNTY**
10 **COMMISSIONERS TO:**

11 **(1) ADVISE AND COUNSEL THE COUNTY COMMISSIONERS,**
12 **COUNTY OFFICIALS, AND COUNTY STAFF IN CONDUCTING THE BUSINESS OF**
13 **THE COUNTY;**

14 **(2) RENDER ANY LEGAL OPINIONS NECESSARY TO CONDUCT THE**
15 **BUSINESS OF THE COUNTY;**

16 **(3) INSTITUTE, PROSECUTE, AND DEFEND LAWSUITS TO WHICH**
17 **THE COUNTY MAY BE A PARTY; OR**

18 **(4) PERFORM ANY OTHER DUTIES AS PROVIDED BY LAW.**

19 **(C) THE OFFICE OF THE COUNTY ATTORNEY MAY EMPLOY**
20 **TEMPORARILY SPECIAL LEGAL COUNSEL TO WORK ON PROBLEMS OF AN**
21 **EXTRAORDINARY NATURE WHEN THE WORK TO BE DONE IS OF SUCH**
22 **CHARACTER OR MAGNITUDE AS TO REQUIRE SERVICES IN ADDITION TO THOSE**
23 **REGULARLY PROVIDED BY THE COUNTY ATTORNEY.**

25 **(a) The County Clerk shall receive an annual salary as provided in the**
26 **budget.**

27 **(b) The County Commissioners may employ[:**

28 **(1) An] AN assistant to the County Clerk at an annual salary as**
29 **provided in the budget[: and**

1 (2) Attorneys for the County Commissioners at annual salaries as
2 provided in the budget].

3 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
4 October 1, 2010.
